From the President

I have some sad news to pass along. Augusta Archers, after a relationship with the VBA for over sixty years, has decided to withdraw from our organization. This decision came from Augusta Archers' President Sam Day, with the support of some of his fellow officers, after he attended the June VBA Quarterly Meeting. During this meeting, there was a heated discussion about Augusta Archers breaking VBA rules when they held R100 shoots for Rinehart, a manufacturer of 3D targets, during the past three years. Sam lost his temper and walked out of the meeting. I would now like to explain to our membership, and especially Augusta Archers members, what has transpired, and the consequences.

Three years ago, Augusta Archers signed a contract with Rinehart to host R100 shoots for that company. Rinehart puts on several R100 shoots at a state level across the nation. Augusta Archers was chosen as the Virginia hosting club. However, the shoot was held on the same weekend as the VBA State Open. The VBA had reserved this weekend for their shoot and, by the rules in its by-laws, no other club in the state, besides the one hosting the Open, is supposed to hold an event on that weekend. Now I realize that Rinehart chose this date, but, although Sam Day and Augusta Archers knew about the date chosen well in advance, there was no attempt by them to resolve this conflict before the event. Sherwood Archers, who held the State Open, were, naturally, upset because they lost some attendance due to this scheduling conflict. At the June VBA Meeting that year, the Board of Directors, after a lengthy discussion, voted to impose the following sanctions against Augusta Archers for violating this rule: the Fall 3D Classic which they were set to host was given to Sherwood Archers, and August Archers was not allowed to bid on state shoots for the following year.

Then, two years ago, at the VBA September Scheduling Meeting, Sam Day and Sam Lenard put a Rinehart R100 shoot on the scheduling card, which reserved that weekend for them to hold a shoot in their zone. This was fine and proper. However, it clearly states on the scheduling card that a one dollar fee is to be paid to the VBA for every shooter participating in shoots, with the exception of one annual shoot for each club. This is also in the VBA by-laws, and has been for many years. Augusta also chose an additional date for their exempt annual. Although Augusta Archers made over four thousand dollars on the Rinehart shoot, they refused to pay the dollar per shooter fee for that shoot, which would have amounted to about two hundred and thirty dollars. VBA Vice President Terry Ballowe and I took the time to drive down to Augusta Archers to try to deal with this situation. We were hit with statements from Augusta members which included: "what is the VBA," "I am going to do what is in the best interest of my club," and "we took a vote and we are not paying." At the following VBA Quarterly Meeting, a lengthy discussion was again held on this matter and a compromise reached, allowing Augusta to swap their exempt annual with the Rinehart shoot.

Last year, at the September Scheduling Meeting, Augusta Archers scheduled a Rinehart R100 shoot for May 31st - June 1st as their annual, which was fine and proper. This reserved the weekend for them and blocked the other two clubs in their zone from scheduling shoots. After I had drafted the schedule card and sent it out to the clubs for review, I was notified by email from Michelle McMillian of Augusta Archers, to remove the Rinehart R100

shoot from the card and set an All Deer September shoot as their annual. As you can see on your schedule card, this was done. On May 10th and 11th, Augusta held the Rinehart R100 shoot anyway. Singers Glen had a shoot scheduled on the card for May 11th. They were naturally upset because they lost shooters due to the conflict. Again, it is clearly stated in the by-laws that two clubs in the same zone cannot host the same type of shoot on the same date. As a side note, since this was Mother's Day, Singers Glen did not really want this date but took it because Augusta had reserved June 1st. Sam Day and Augusta Archers had to know by January about this date for the Rinehart shoot and should have known about the conflict. But nothing was said at either the January or March VBA Quarterly meetings, and no effort was made to contact Singers Glen. In fact, no effort was made to notify the VBA or other clubs in their area that Augusta was hosting this event, which the VBA would have been happy to support, and help to resolve any conflicts. These actions brought us up to the June VBA meeting last weekend, where discussion was begun in order to understand and resolve these issues.

I believe that Sam Day is trying to blame the VBA for all these problems and situations. I do not believe he understands what the VBA is and how it operates. I have heard, through the grapevine, that he has spoken badly about the VBA, and he has as much as admitted that he allows and encourages members in his club not to join the VBA. Perhaps I need to explain again to Sam, Augusta Archers members, and to you, what is the Virginia Bowhunters Association.

Basically, the VBA is a group of local archery clubs that have joined together to form a state organization to promote archery in all aspects of the sport and to work together for the benefit of all archers. Many articles have been written about the accomplishments of the VBA, including our archery hunting season, awards programs, scholarships, state tournaments, etc. But that is not really what we are about. I believe we are organized to try to help one another, and help our sport prosper. I have heard Sam say, "If you do not shoot in tournaments you don't need to join the VBA." Again, anyone who says this has missed the point. While I will admit that a fair amount of VBA time is spent on tournaments, this has never been our sole objective. The VBA sets shooting rules and schedules shoots so that the local clubs operate on the same level and do not conflict with one another. Tournament shooting is a large part of the VBA. However, the main purpose of the VBA has always been for the clubs to support one another and the sport of archery in all its complexity. The clubs have set rules to avoid conflicts such as the ones above. While all clubs are not in agreement over all issues, they work by majority votes and strive to do things to help all clubs and the individual members. Over the past 60 years, Augusta Archers has been a part of this and has voted on all these rules.

So why do all the members of the clubs have to belong to the VBA? That is the way it was set up by the clubs; it is in the VBA's Constitution and By-laws. It is really a numbers game. The more members we have, the more influence we have on organizations such as the Department of Game and Inland Fisheries, and the Virginia legislature. It also gives us more income to have such things as a scholarship fund and a conservation fund, it allows us to send representatives to the Department of Game meetings, it allows for help with education courses, and with award programs. Need I go on?

With this information in mind, let us get back to Sam Day and Augusta Archers. All the problems and conflicts that have occurred could have been avoided if Sam and Augusta would have communicated with the VBA. The VBA is not opposed to Augusta hosting the Rinehart R100 shoots. In fact, the VBA would like to support the holding of these shoots. It is a good thing for archery, your club, and all archers. I have heard others say, and I believe it also, that it is good that a VBA club was hosting the Rinehart R100 shoots. I encouraged Augusta to put it on the schedule card so all VBA members would know about it. I think if it had been kept there, more VBA members would have attended. Any conflicts could have been worked out in advance. The VBA and its member clubs were there to support Augusta Archers however we could. Rather than trying to work with the VBA and its supporting clubs, I believe Sam Day said to hell with them, we are going to do whatever we want since it will make our club a lot of money.

To the membership of Augusta Archers - I am very sad that your president and other officers have decided to withdraw from the VBA. Augusta has a very long history with the VBA and has been an active club. Personally, I have attended and enjoyed many fine shoots at your club over the years. Although Augusta Archers is no longer associated with the VBA, your individual membership is still valid to the end of the year, and I hope many of you will join and support the VBA next year. To Sam Day, you have said that you will do whatever is in the best interest of your club; I do not believe that withdrawing from the VBA serves that purpose but I do hope for the best for you and Augusta Archers in the future. 🍷

From the Executive Vice President

Hope everyone has had a great spring and a grand start to the summer. I would like to start by saying that the Manahoac Archers did an excellent job with the implantation of the new VBA 3-D rules with our changing to a IBO rules format, there were a couple of small bumps in the road but nothing earth shattering and those problems were addressed at the last VBA quarterly meeting. I knew that in changing to new format would cause some problems but everything was handled and I don't see any major problems for the Fall 3-D classic to be held at Kingsboro in Aug.

The VBA Open was held at Sherwood archery club in Roanoke and they did a great job in hosting the shoot as always. I did not make it down to shoot myself but by everything I was told was positive and they had a good but not a great turnout for the Open.

I would like to stress to the VBA membership that the clubs need your support and by support I mean go to scheduled shoots, the majority of the clubs income is from people attending the club and state shoots. Without this support your clubs can not afford to keep the ranges and targets in good condition, if you have not checked the price of 3-D and Field target material you should, because it is not cheap and without your support your local clubs could disappear forever.

Now onto a subject I would like to not have to address but as a VBA officer I need to put my two cents in even though in the Presidents article all aspects of the problem were pretty much covered. I would like to state that none of the officers wanted the Augusta archers to drop out of the VBA even though they have continually broke the rules of the VBA and sanctions were voted on but not before Augusta's President Sam Day stormed out of the quarterly meeting with an few expletives on the way out the door and later that evening we were informed that they were dropping out of the VBA and I don't see how they could have had a club vote on whether to drop out of the VBA or to accept the sanctions that were voted on in that short of time. I have been to several shoots at Augusta and I would like to say that I have had a great relationship with the members of Augusta and will probably be back to shoot there again but I cannot understand why they have continued to violate the rules that they have been part of instituting, as they have been a part of the VBA for over sixty years, most of the rules they broke were voted into the constitution and bylaws with the help of Augusta Archers. I hope Augusta membership will look at this decision by Sam to withdraw from the VBA and reverse that decision and abide by the rules of the VBA. If you don't like a rule the VBA has there is a way to change the rule and that is by having your club introduce an agenda item at the next quarterly meeting and letting the membership of the VBA decide if it should be changed, this is an organization that is not controlled by the executive board but rather by the majority vote of the membership. With one last point I would like to point out that if the leadership of Augusta Archers had just simply picked up the phone and called someone on the executive board about the issues that took place the board could have met with the club delegates and found a way to accommodate all parties involved and NONE of the violations would have happened, the only shoot date that is locked in stone is the VBA STATE CLOSED which is always held on Labor Day weekend, everything else is subject to CHANGE. At the quarterly meeting Sam repeatedly stated that Augusta archers could not walk away from all of the money that was coming in from the Rinehart shoot and I understand that the flow of cash that comes from that one shoot is important to the club, but one thing that he is not admitting to or does not realize is that the Rinehart shoot will move to a different location soon and that flow of cash will disappear leaving the club out in the cold without the big shoot and the VBA. The VBA wants the Augusta archery club to remain in the organization and will work with the club and Rinehart to hold their shoot but it will only work with a little communication and that is where all of the problems started at, No communication from the club to the VBA.

From the NBEF/IBEP Director

Without a doubt, fall is the favorite season for Bowhunters! Whether you are getting ready for that once in a lifetime guided hunt, or looking forward to climbing your best stand on your farm or lease, it is just a great time of anticipation. But as you get ready, one of the things you need to make sure you do is to pull out all of your climbing stands, lock-on stands, climbing sticks, and all the other essential equipment you anticipate using. Now is the time to give them a really good inspection. Look for wear and tear, and make that critical decision as to whether they need to be replaced. Check welds and straps to make sure they still operate as designed by the Manufacturer. When in doubt, replace them with Original Equipment from the Manufacturer (OEM). Never leave anything to chance when it comes to your personal safety!

Spring is also the time to look over all the new equipment being offered to see if it would add value to your hunting set up. Here are a couple that caught my eye this year.


Safety First! One of the most interesting products is an improvement on the Tree Spider Fall Restraint System offered by Robinson Outdoors. You may recall that their Livewire product is designed to automatically lower you safely to the ground if you fall out of your treestand. This year they are offering Tree Spider iHunt - a half dollar sized device that connects between your safety harness and the tether that secures you to the tree when in a treestand. If you fall from your stand, it will trigger a message to be sent to your smartphone and the iHunt app that you install it on. Using your phone's GPS, your exact coordinates will be sent out with an emergency call for help. The iHunt Fall Call works with any and all safety harnesses, and doesn't require any additional fees or charges. All you need is a smartphone that can connect via bluetooth.

A product that I consider to be a "must have" for both vertical and crossbow hunters are lighted nocks. Five years ago there were only a very few choices (Coyote Luminocks and Firenocks come to mind). This year there are offerings from numerous manufacturers in a variety of colors, sizes and designs. The bottom line is that many of today's bows shoot so fast that it is almost impossible to see the flight of your arrow in low light conditions. With a lighted nock, it looks like a laser beam going away from you, so you can see where your arrow hit. You can also walk straight to it and pick it up when you get down out of your stand. Both are critical skills for successfully recovering deer. A really unique innovation is the Helios Lightednocks from Nocturnal. These nocks combine fletching designed to put an aggressive spin on your arrow with a lighted nock, resulting in flight stability as well as the ability to see them. The large number being offered has also driven down the price – you can pick up three for under \$30. Well worth the investment.

One final product is She-Duction Scent Web by Away Hunting. This product resembles the canned spray "strings" that have become popular at parties. The difference is that the "string" contains an all-season scent that is designed to attract bucks during the pre-rut, rut and post-rut.

The string clings to vegetation and remains powerful for up to five days. The spray nozzle shoots the string up to 10 feet, and doesn't wash away in rain or snow. In fact, the manufacturer says it is reactivated by moisture.

AGENDA ITEMS

AGENDA ITEMS VOTED ON AT JUNE MEETING:

(7) Change VBA Rules and Styles, Sect. 1, Outdoor Classifications, Pg. 7; Senior, Silver Senior and Master Senior, by removing the words, “no class breakdown in this division,” and inserting the words in each category, “same class breakdown as adult men and adult women.” Add a heading to this paragraph to read: Male and Female. Effective on passage of motion. **Passed 33-3.**

(8) VBA By-Laws, Art. 3, Sect.3.2, Flight Editor, Pg. 44 of 22; Change last sentence and add a sentence as follows: He/She shall cause this publication to be made available to at least one member of each household of an affiliated club and associated member of this association by regular mail, e-mail or by access to a downloadable copy from the VBA Website. Members wishing to receive the publication by email must request that mode of delivery and provide the editor with an e-mail address. Effective, Jan. 2015. **Passed, unanimous, 36-0.**

(9) Motion to create an Affiliate Membership Classification, Art. 3, Sect.3.3; for corporations, clubs, and/or organizations wanting to affiliate with the VBA, including a fee of \$50.00 with no voting rights. Passed, 32-4.

(10) By-laws, Sect. 15, 2.4, Pg. 13, Sanctioned Tournaments: remove, “for Indoor, Field, Hunter and Paper Animals.” Effective, July, 1, 2014. **Passed 34-2.**

(11) By-laws, Sect. 15, 1.10, Registration Fees, Pg. 12, D; remove “Field/Hunter and 3-D”. Add “for any sanctioned tournament.” Effective, July 1, 2014. **Passed, unanimous, 36-0.**

AGENDA ITEM FOR SEPTEMBER MEETING:

(1) Amend Art. 15-Tournaments, Sect. 15, 1.10-Registration Fees, Para. A., first sentence, Page 11 of 22, to read: “Registration fees for the State Open, Closed and Indoor Tournaments shall be \$20.00 each for the first two (2) adult archers, \$5.00 each for the first two (2) youth (under 18) archers, with a maximum of \$50.00 per family.” Effective, Jan. 1, 2015.

Justification: Necessary in order to keep pace with the increased cost of targets and the increased cost of repairing and replacing target butts.

After switching to the IBO rules, there was some confusion at the first State 3D Shoot. The Tournament Committee was asked to address a few issues:

1. The host club will have help for those who need direction on styles and stakes to shoot from. The IBO styles are a little different and have some options to choose from.
 - A. The Future Bowhunter (FBH) is for kids eight years old and younger. This is a non-competitive class where kids shoot ten targets, do not keep score and there is no fee. All participants in this division receive an award for their participation. This is to promote archery and help beginners. If a child wishes to participate for regular awards, he/she may register as a Cub (for children up to twelve years of age).
 - B. IBO has a Bowhunter division with four class breakdowns for the beginning adult archer using hunting equipment. Those shooting in these divisions are not competing with experienced archers and shoot a maximum distance of 35 yards.

So all you Bowhunters come out and try the Fall State 3D Shoot and support your clubs and VBA

All IBO rules and division can be downloaded from the IBO website for information on classes and styles, the only styles that the VBA does not have that the IBO has is Pros and Crossbows. The Tournament Committee hopes this clarifies the two concerns brought up at the spring shoot.

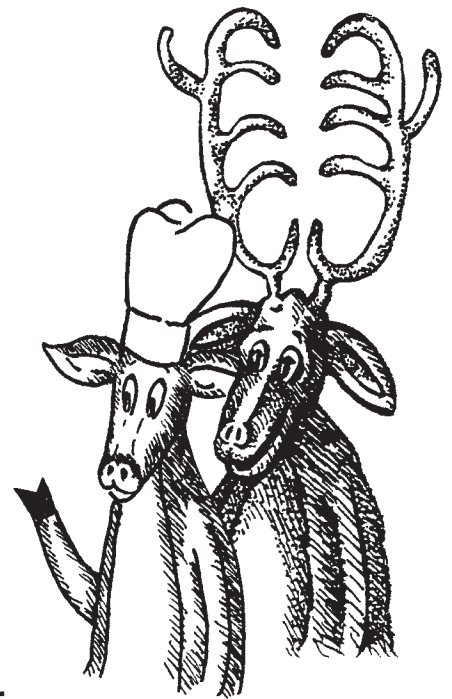

11th NASP® National Championship in Kentucky Attracts 10,500 Student Archers

The largest archery tournament in the world again returned to Louisville Kentucky's Exposition Center May 8-10, 2014 with over 10,500 archers taking their place on the range for the 11th annual NASP® national tournament. In 2012 this event was certified by Guinness® World Records as the largest archery tournament in the world with 7,804 archers. This year 10,800 archers were registered. ELK RESTORATION UPDATE

Update Elk Release Completed April 2014

Wildlife biologists with the Virginia Department of Game and Inland Fisheries (VDGIF) made the final transport to move 45 more elk to Buchanan County from southeastern Kentucky on April 10-11. VDGIF and Kentucky Department of Fish and Wildlife Resources employees trapped elk in January in Kentucky. The elk were tested for infectious diseases and held in quarantine in Kentucky until their historic transport to the release site in the Warfork area of Buchanan County, now firmly established as the “Elk Capital of Virginia”. The elk were placed in an acclimation corral before being soft released into their new habitat. All adult elk wore new GPS telemetry collars so that biologists could monitor their movements following release. These elk will join 16 elk brought to Buchanan County in 2012 and 10 in 2013. The elk previously released near Vansant have multiplied to a small herd of about 40. The release this year will double that number and result in over 100 elk in the release area after calving by June. VDGIF intends to allow the Buchanan County herd to grow to 400 elk. It will take a number of years to reach that number, but limited hunting of bulls can occur before then without slowing herd growth.

VDGIF Regional Wildlife Manager and Elk Restoration Project Leader Allen Boynton notes, “Virginia has been very fortunate to have the support of the Kentucky Department of Fish and Wildlife Resources, the Rocky Mountain Elk Foundation and Buchanan County during this four year project. The Kentucky wildlife staff have taught the VDGIF biologists how to capture and handle elk. They have spent many hours each winter trapping elk for release in Virginia. We now have a strong partnership with the Kentucky staff in elk management that will benefit our restoration program for years to come.”

WORKING TOGETHER TO MAKE A DIFFERENCE

The Rappahannock River Valley National Wildlife Refuge (NWR) is part of the Eastern Virginia Rivers National Wildlife Refuge Complex, a four refuge complex including Rappahannock River Valley, James River, Plum Tree Island and Presquile NWR's. The Rappahannock River Valley National Wildlife Refuge was established on May 28th, 1996 as part of the National Wildlife Refuge System to conserve and protect fish and wildlife resources, including endangered and threatened species and wetlands, from the risk of development and destruction. The refuge has an acquisition boundary of 268,000 acres and stretches over 60 river miles from Port Royal in Caroline County to Lancaster County Virginia. Within its acquisition boundary, the refuge is authorized to acquire up to 20,000 acres of high priority lands through fee title purchase or conservation easements. Over the past 16 years, the refuge has grown to more than 8700 acres of valuable habitats protecting and managing habitat for over 230 species of migratory birds. Protected species include neotropical migrants, waterfowl, wading birds, and America's national symbol: the bald eagle. Although the Rappahannock River Valley NWR was established to protect habitat for migratory birds, it is also home to other species of wildlife that use this mosaic of important habitats including White-tailed deer, Wild Turkey, Northern Bobwhite, beaver, river otter, and many others.

The refuge utilizes a variety of habitat management techniques and surveys to improve and maintain quality habitat for the trust resources that the U.S. Fish and Wildlife Service is responsible for. Some of these management techniques include reforestation of retired agricultural fields, mowing and prescribed fire of native grasslands, and invasive species control. Refuge staff and researchers also conduct a variety of surveys to monitor habitat quality, wildlife population levels and wildlife response to habitat management techniques, such as breeding bird, duck banding, eagle migration, and vegetation surveys.



In addition to the focus on serving as a sanctuary for migratory birds, the Rappahannock River Valley NWR offers all of the wildlife dependent recreational opportunities identified in the National Wildlife Refuge System Improvement Act of 1997: hunting, fishing, environmental education, interpretation, wildlife observation and photography. The refuge is opened to a permitted deer hunt through the Virginia Quota Hunt Lottery System. Hunting opportunities include archery, muzzle loader and shotgun. The refuge has three designated locations for fishing at Wilna pond, Laurel Grove pond and Mt. Landing Creek. Refuge staff, volunteers and partners provide nature walks, tours, school programs, presentations, and participate in community outreach events both on and off refuge. Facilities for wildlife dependent recreational opportunities on the refuge include approximately nine miles of roads, 6 miles of pedestrian trails and a 3.5 mile water trail, informational kiosks, fishing piers, canoe/kayak launch sites, photo blinds and visitor contact area at the refuge headquarters.

Refuge staff realizes that we cannot manage and protect these fragile natural resources, and offer opportunities for the public to gain an understanding and appreciation for these resources alone. So, Rappahannock River Valley NWR also relies heavily on the support of the Rappahannock Wildlife Refuge Friends, volunteers and partners to get the job done. The refuge Friend's Group is dedicated to supporting the National Wildlife Refuge System, and promoting the awareness of the Rappahannock River Valley National Wildlife Refuge System through education and support. Many members of the Friends Group also serve as volunteers working on a variety of projects, events/programs and tasks including: construct and maintain facilities- trails, native plant gardens, fishing piers, mowing, etc.; biological surveys and habitat management- bird surveys, tree planting, invasive species control, etc.; visitor services- on and off refuge community outreach events, lead nature walks, school programs, etc. These are just a few of the areas volunteers can get involved. If you care about natural resources and you have an interest in getting involved and seeing how you can help, we encourage you to join the Rappahannock Wildlife Refuge Friends at <http://www.rwrfriends.org/> to stay in tune with happenings on the refuge. NOMINATIONS DUE IN MARCH

The VBA Order of the Golden Feather was created to honor those persons who have given unselfishly of their time and talents toward the betterment of archery and archers. Recipients are persons who possess the virtues of sportsmanship, character, morals, integrity and friendship. As a reflection of the substance for membership, only 80 people have been elected to the Order in the past 71 years.

To be qualified, a candidate must be member in good standing of the VBA at the time of nomination, must have a minimum of ten successive years' membership in the VBA and must be sponsored by three VBA members of good standing or by a VBA Club.

This article is a reminder that candidates must be submitted to the Board of Directors at the March meeting for this year. Nominations must be in writing and be signed by sponsoring individuals or a Club officer. Successful nominees have always performed duties or had an impact outside their immediate club.
