

From The Hunting Vice President _

The power and seriousness of the anti-hunter has finally been brought to light for many, especially in the state of New Jersey. In October 1986, the trappers of N.J. lost the right to trap. Not satisfied with the ban on trapping, the antihunters, with the support of assemblyman D.B. Mauzur, have introduced two bills that would ban bowhunting in the state of New Jersey. This bill would make it illegal to take any animal or fish with a bow and arrow in the state. The possibility of stopping bowhunting in N.J. is very real and, if it happens, it may set the stage for similar anti-hunting activities in other states. Geographically, Va. is not that far from N.J., and our state could possibly be the next one on the anti-hunters list.

New Jersey bowhunters need the help and support of bowhunters across the country to keep and protect the sport they enjoy. In the March meeting of the

Changes to NFAA Constitution and Bylaws

Page 24, Article II, Section A, Add new paragraph 5 as follows: (This Section deals with shooting equipment rules). All overdraws shall be designed in such a fashion as to prevent arrows from falling off the rest, and endangering competitors.

Page 24, Article II, Section B. (This section pertains to shooting equipment rules for Barebow). Add the following sentence to paragraph 5. Mechanical type arrow rests and cushion plungers are legal.

Page 25, Article II, Section E (This section pertains to shooting equipment rules for Competitive Bowhunter). It would add the following words to para-graph 3. "and or cushion plungers." The complete sentence would now read: "There shall be no device, mechanical or otherwise, in the sight window except the arrow rest and or cushion plunger."

Page 25, Article II, Section E. This change would delete the following two paragraphs from Competitive Bowhunter shooting equipment rules:

4. Any part of the arrow rest extending more than 1/4 inch above the arrow is deemed illegal in the Competitive Bowhunter style.

5. An arrow plate extending more than 1/4 inch above the arrow is deemed illegal in the Competitive Bowhunter style.

A new paragraph would be added as follows: "Nocking point locators shall not extend more than 1/2 inch above or below the arrow nock at full draw.'

Page 25, Article II, Section E, Para-graph 7. Paragraph 7 which reads as follows would be deleted: "A sight window may be altered from standard configuration providing that no lamination, blemish, protrusion, or any identifiable mark could be used for an aiming reference is visible." Note: Deletion of paragraph 7 would allow bows with technical innovations such as the PSE Centerflite riser to be legal in all styles of shooting.

Page 26, Article II, Section E, Paragraph 16. Paragraph 16 pertains to shooting equipment rules for Competitive Bowhunter. The paragraph would be changed to read: "There shall be no restrictions on the bow draw weight. Arrows must be equipped with a minimum of 125 grain point for men and a minimum of 100 grain point for women." Note: Deleted is the requirement that arrows be equipped with commercially manufactured, non-modified points that can be replaced by broadheads.

Page 3, Article IV, Section K, Add new paragraph 3a as follows: "20 cm targets will be shot vertically. The shooter may elect to shoot top to bottom or bottom to top."

Page 57, Article VI, Section J, add new paragraph 4c as follows: "A penalty of one point will be assessed for each arrow shot over the prescribed number." Note: This change will bring scoring for the Championship round into line with the NFAA Indoor Round.

For You The Archer

Tuning Tips:

For this writing we are going to look at a few commonly used terms in tuning, and look at their definitions, causes, and effects. We are not going into bare shaft tuning, paper tuning or some of the other tuning methods. I feel some of those methods can get complicated, and unless there is an interest in getting that technical I plan to keep this column as simple as possible.

The first one we will study is porpoising. This condition is when there is a vertical up/down movement of the arrow when it leaves the bow. This condition is brought about by an incorrect nocking point. The simplest way to correct this problem is to shoot an arrow into a butt on a horizontal plane at about 20 feet. Look how the nock end of the arrow is pointing, it should be pointing straight back at you. If the arrow is pointed down, your nocking point is to low; if it is pointing up, your nocking point is too high. After noting which way your arrow is pointing, you simply adjust the nock locator up and down the string until you get the arrow nock looking back at you from the bale.

The next condition we will look at is Fishtailing. This is when the arrow has side to side movement on the horizontal plane when it leaves the bow. This condition is sometimes harder to correct than porpoising but must be corrected if you are going to shoot consistant groups. Again this testing should be done at close range. The most probable cause is rest alignment or incorrect pressure on a pressure button. Again we shoot into a bale and pay attention which way the arrow points. It will either point straight back at us or it will be kicked to the right or left. By adding or subtracting spring tension on the button or moving the rest in or out we can alter how the arrow enters the bale. Don't be afraid to play to find out what happens if you change things, that is the only way we learn what works best for us. Sometimes the wrong arrow spine can cause fishtailing, if this is the case please refer to the article in the last Flight to find the right spine for your needs.

The last condition we are going to

look at for this writing is clearance: This condition is when the arrow strikes the bow and does not clear. This condition is usually caused by an improperly set pressure button, the rest to close to the riser, or you are shooting an improperly spined arrow, all of these conditions have been examined earlier and you should refer back to earlier mentioned tuning tips.

For the bowhunter:

When turkey hunting, I like duller broadheads than I use for deer hunting. The reason being I feel I want a little more shocking power than penetatration for bird hunting. I like using the MA3, Bodkin, or HI Standard Fixed 3 blade broadhead for turkeys. I find they fly well and are quite effective: Again, I remind you to be safety conscious when turkey hunting.

Safety Tip:

When you are looking for arrows that have missed the butt, always put the red flag on the butt or have someone stand in front of the butt while you look for your arrow. If you are alone, remove the target from the butt and place your bow in front of the butt. These simple tips can keep someone from getting injured or killed.
