

To VBA Members:

I recently had the misfortune of being one of seven individuals to witness blatant rules infractions at the VBA Indoor Championships at Christiansburg. After observing these infractions for ten ends, I, along with other witnesses, informed tournament officials of the infractions. Mr. Steve Hiner and Mr. Larry Lyons observed these infractions and told us that we would have to file a formal protest in order to have the situation resolved. We told these tournament officials that, if they could within the rules, we would rather the situation be handled by tournament officials. Mr. Hiner told us that he would have a ruling the next day on how the issue should be handled.


The following morning we were told that there would be a meeting of the tournament committee immediately following the first round. Upon completing shooting the first round, I approached Mr. Jim Overfelt and asked him when the meeting was to take place. Mr. Overfelt then informed me that no meeting was to take place and that the people involved with scoring the target butt in question "had no problem with the scoring". Upon hearing this, I told Mr. Overfelt that I would like to file a formal protest and that the other six witnesses were ready to sign it. Mr. Overfelt then informed me that we did not have grounds for a formal protest. Upon hearing this I left in disgust.

I have been in organized archery for five years now. I know what results when infractions of the rules are not handled properly. I was wrong in not pursuing the matter in question further. I have seen no less than two clubs torn apart by this very divisive issue. In the future, we, as participants, must insist upon strict adherence to rules in order to protect competitive archery and our competitors as individual participants. This should begin by electing a VBA Field Governor who will make every valid attempt to attend each state championship shoot and see to it that such situations are resolved. In addition, we should elect other officers who we know will protect the integrity of their office.

In closing I would like to encourage each VBA member to vote for VBA officers in the upcoming election. This voting should be done solely on the known merits of the person seeking the office. A sound organization must have sound leadership.



## **Javelina Junting**

I was glad for the opportunity to return to Texas with Dave Proctor and 2 friends from South Carolina for some Javelina Hunting.

The date had been set for Jan. 18th, but Mother Nature was acting up again. For the first time ever it was snowing in Southern Texas, down as far as San Antonio which was only 100-150 miles from our hunting area. After checking weather reports and with the ranch in Texas, we decided to proceed.

On Friday, Dave and I loaded up the van and left for Aikens, South Carolina to pick up Richard Grubbs and Chip Williams. We left Aikens at 9:30 Friday night and arrived in Beaumont, Texas about 2 p.m. Saturday, and stopped overnight outside Houston. Sunday we proceeded to Laredo, arriving about 3:30 p.m.

This ranch was raising some exotic game animals. We toured the ranch and observed Audad sheep, Black Buck, Elk and Antelope. No hunting was allowed: All we could do was look and drool.

We arrived at our final destination, a ranch about 70 miles from Laredo. The weather so far had been great; no snow, ice or real cold.

Monday morning was clear and cold (about 30°), but it warmed up to 45-50° by 9-10 o'clock. We saw our first javelina, a group of 10-12 pigs and we all put the sneak on them. Richard took a couple of shots and missed. They spooked off and we proceeded to hunt for more.

We spotted another group, stalked, and got within 15 yards. I took a kneeling shot at one and shot high. Now, we are in some fairly thick mesquite and prickly pear and believe me those mesquite trees (or bushes) are hard. That arrow hit a mesquite limb and bounced off. 1 bent arrow. I sneaked in a little

closer to another pig that was standing on the other side of the prickly pear. He spooked and came flying aroud that prickly pear and headed right between my legs.

A Javelina (known as collared Peccary—PEK-A-RI) averages 45-50 lbs. They have hair like wire on their back which stands up when spooked, making them seem considerably larger. They have tusks about 1½" long and they slap their jaws together making a popping sound.

Man, it is absolutely amazing how high and far to the right a 56 year old man can jump under these circumstances and all at full draw.

During this flurry everybody got a couple of shots and Richard connected. Dave decided to still hunt through the mesquite and when we got together later, he had a pig. That day we counted up 14 bent arrows and 2 pigs.

We had a video camera and recorded for posterity the successful shots by Richard Grubbs, the misses (3 by Day Proctor—one right after the other) goo ups by Owen and Chip (we spent 30-40 mins. fishing Chip's arrow out of a pond), and a fine time by all.

My hunting buddies let me learn the hard way about prickly pear. Those

things will eat you up.

I connected with a pig on Wed. and Friday, Dave collected another on Tuesday and Chip on Wednesday. Thursday we took a side trip down to Mexico to buy mementos and blankets (I believe about 43).

For action and bowhunting, this was really great. You had to take shots, over, under, around mesquite and prickly pear. Kneeling, standing, bent over and every position. You had to shoot quickly and stalking these critters was fantastic. Their noses were very keen and their eyesight was not the greatest, but once they spotted your movement, you had a job getting close enough for an open shot.

I would like to suggest to all you bowhunters to start looking for opportunities and make plans to go on hunts. There are many opportunities available, and with proper planning will fit almost

any budget.

We were fortunate to have a private ranch to hunt on with a Lodge available at no cost.

You are passing up many great experiences and a lot of fun. Don't keep putting it off until it is too late.


