6. NFAA Rules 9th Edition Prevail
7. First round score classifies.
8. Club Team award, 4 archers per team, for sights and instinctive division will be given away free and engraved with the winners names on it!
9. Standard NFAA 40 cm target will be shot.
10. VBA Scoring System used.
11. If you are going to be late call us. You can have someone register for you.

12. You must have your NFAA dues paid.
13. Trophies will be given for 1st, 2nd, & 3rd.
14. State Champion Patch will also be given to each Division winner; women freestyle, youth Barebow etc.

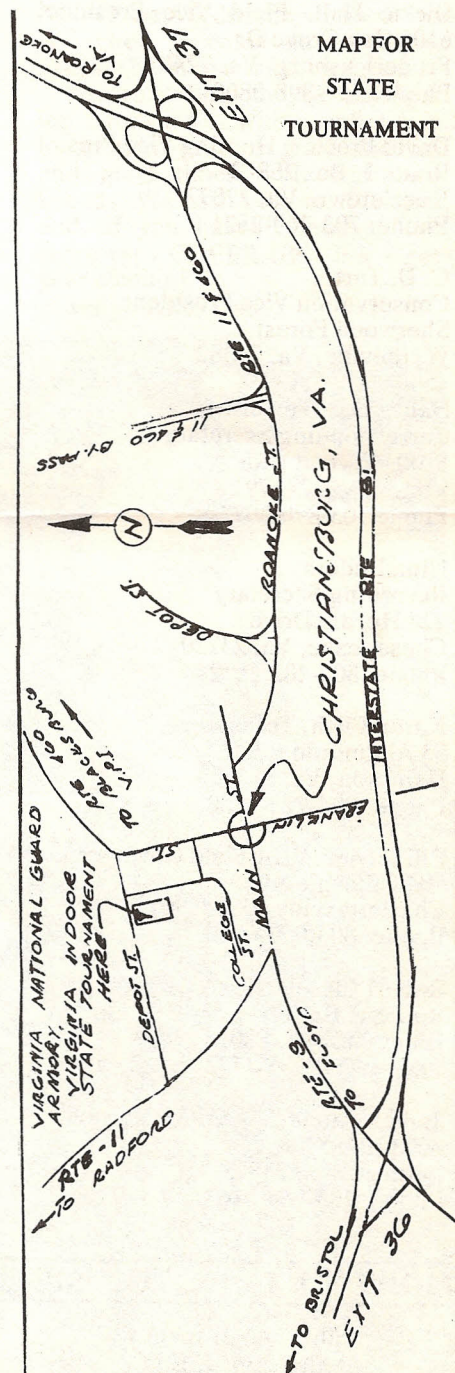

## VBA MEETING HIGHLIGHTS

The January VBA meeting went very nicely; 14 clubs were represented.

Our Hunting Vice-President, Dave Proctor reported that he had received 41 Big Game applications, 30 for bucks and 11 for doe. The largest kill was a 165 lb., 8 point buck.

NFAA Director, Bob Cissel summarized the agenda items for the NFAA National meeting in February. On 2 important items, Cissel was instructed to vote NO. They were: 1. To leave the present targets alone and 2. Do not go to the metric distances.

The Mid-Atlantic Sectional will be hosted by Baltimore Bowmen on June 20-21, 1981.

Due to an apparent lack of interest and no resulting bids, the Mid-Atlantic Indoor Sectional will not be held this year.

It was decided that the VBA would hold a raffle and final plans would be completed and tickets distributed to clubs by March meeting. 2000 tickets will be printed with each ticket being sold for \$2.00 each.

1st prize: All expense paid hunting trip to Colorado.

2nd prize: Compound Bow of winner's choice.

3rd prize: Custom made hunting knife.

\*\*\*All four agenda items before the delegates at the January meeting were defeated.

\*\*\*The committee formed to study the whole classification system recommended no change at this time.

John Stockman was appointed to chair this year's nominating committee. David Arbogast, Piggy Hogge, and Bill Smiley will serve with John. Anyone knowing someone or desiring to serve as an officer should contact the committee member in your area prior to the March VBA meeting.

Field Vice-President Dickie Hall asked all clubs if they could possibly buy a year's supply of pins at one time. This would put the money back into the treasury faster and the club directors could pick the pins up at the VBA meeting, thus saving the clubs some money on postage.

The next quarterly VBA meeting will be March 28-29, 1981 at the Mount Vernon Motel in Charlottesville. Be sure to have a director there.

## Agenda Items for March

1. (Princess Anne) They moved that the VBA do away with the Virginia Pro Division.

2. (Sherwood) They moved on behalf of the Order of the Golden Feather that article 16 of the By-Laws be amended to provide that candidates be submitted to the VBA Board of Directors at the March meeting (or April meeting as the case may be) and that ballots be issued and a vote taken at the June meeting on any candidate(s) to to be submitted to the Order for approval. (Note: In anticipation of Article 16 passing, nominations for the OGF will be accepted at the March 1981 meeting if directors present will so approve by unanimous approval.)

3. (Blackwater) They moved that the CFBH-AA unlimited class be changed to read "485-560".

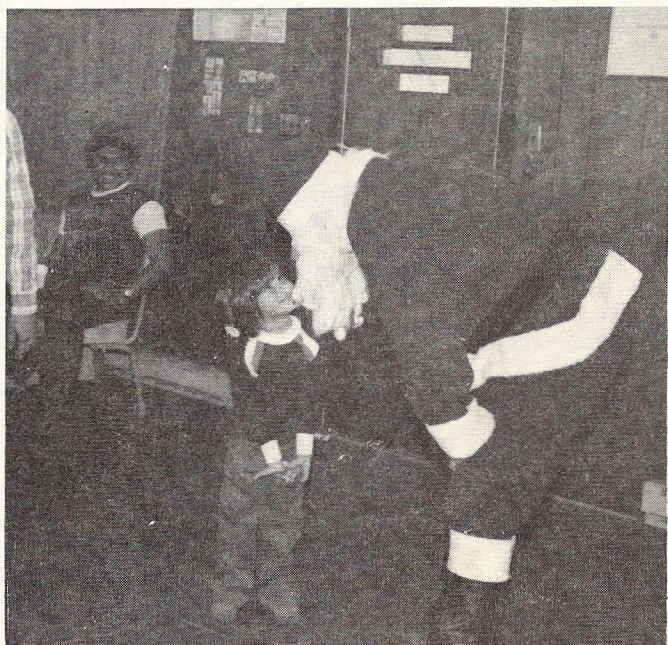
