### VBA PRESIDENT BEHIND THE GAVEL

Last month Gene Limerick and I attended a mid-Atlantic Sectional Meeting of NFAA delegates at Harrisburg, Penn. Some of the items to be placed on the agenda for the February 1968, Kansas City meeting were proposed and discussed. In attendance at Harris burg were the presidents of Penn. and N.J.; Bill Boyle, NFAA councilman for mid-Atlantic; Mrs. Boyle representing N.Y.; and a delegate from Delaware.

We did not commit our state on any issue but did present agenda items for the February meeting. A brief summary of items covered are:

12. Reciprocal agreements between states on non-resident memberships.

By this list you can readily see that we need your club delegates at the January VBA meeting to properly eval— uate and instruct our delegation to the February meeting in Kansas City.

Briefly let me ask all of you who have not sent in your bare bow questionaire to please do so immediately.
A quick summary of the first 150
ballots returned indicate that there
is great concern on these vital questions. The comments some archers
wrote are extremely beneficial to wrote are extremely beneficial to your officers. A sample of the first 150 returned indicate that 94 agree to #1 (leave as is); 14 agree to #2 (separate divisions); 44 agree to #3 (free-style division); and 27 agree to #4 (new bow-hunter division).
