



## FIELD GOVERNORS OK NFAA REORGANIZATION

Reorganization—a word used quite often in field archery circles lately as a hopeful method of progressing archery is now a reality.

The National Field Archery Association is now a Federation of State Associations with mandatory membership through the classification system. The measure was passed by a vote of 10,446 to 1,714.

In order to compete in any tournament, including club tournaments, using any official NFAA rounds, the archer must possess, or make application, for a classification card. In order to obtain a classification card, the archer must pay the VBA and NFAA membership fees.

Archers who do not compete, or participate in, tournaments falling into this category, or just "shoot for fun" on club ranges, are not required to join the NFAA. Conditions of membership in the VBA, which exceed the foregoing, remain in effect.

At the first meeting of the newly formed Board of Directors of the NFAA, held in Springfield, Illinois, on February 4, 5, and 6, dues were reduced from \$2.75 to \$1.00 per individual with a \$3.00 maximum family membership. There will be no prorating of dues already paid. Clubs should make checks payable to VBA, as the matter

of administration has been delegated to the states.

It is hoped that reorganization will give the NFAA additional unity and strength. The chain-of-command through the Federation will continue to do the best in the interest of all archers, as for the first time in the history of archery the individual will have unity from the national, the state, the club, and individual level.

Through reorganization the NFAA will have, members in number to be able to present an image of size. Size determines how effective archery's voice can be for the benefit of all.

NFAA will have money for administration and promotion. This comes automatically with increased membership. Each of us is aware that resources determine the extent of our efforts. The only approach is through a single source.

NFAA will have subordinate organizations that fully support a national program complying with rules and policies set out by the NFAA through a democratic process.

There will be communication with the membership and adequate media to all archers and prospective archers.

VBA's support of the theory or reorganization throughout the past years, shows that Virginia's archers stand by to support any effort to progress our sport.

## SHERWOOD ARCHERS TO BE HOST FOR STATE SHOOT

The Sherwood Archers of Roanoke will be the host club of the 20th Annual VBA State Championship tournament.

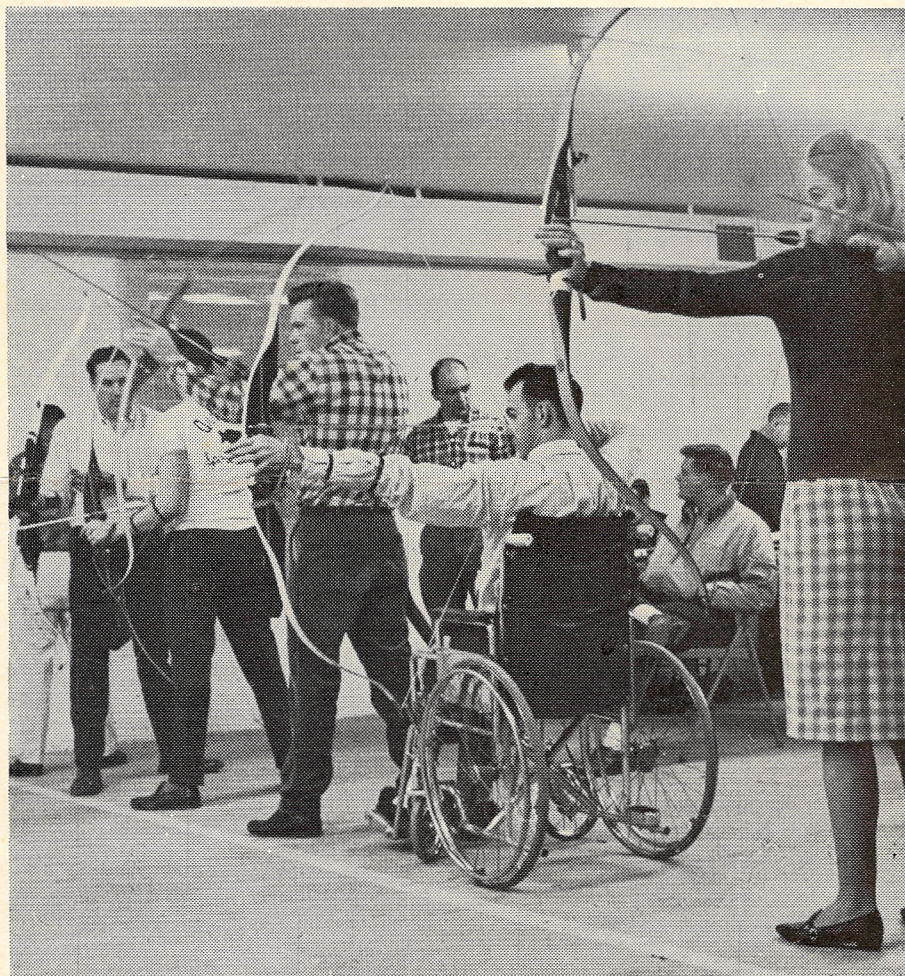

The tournament was held at the Jaycee building near Flat Top's field range in Bedford.

## MOTORISTS HUNT DEER TOO

One rather tragic result of North America's booming deer population in recent years has been a corresponding increase in the number of deer-vehicle collisions on the nation's highways.

For the past two years, Fred A. Thompson, of the New Mexico Department of Game and Fish, has made a nationwide survey of this deer-vehicle collision problem through a questionnaire sent to each of the 50 states.

The number of deer killed on the highways in 1963, including confirmed and estimated kills, totalled 71,073. In 1964 the total was 87,927 up 24 per cent over 1963. The 1964 totals include 54,402 reported deer kills in 31 states and an estimated loss of 33,525 deer in 14 states.

Based on an average of 1,758 deer kills per state, the loss for all 50 states during 1964 would be over 96,000 animals killed on roads and highways.

Pennsylvania again led the nation in reported vehicle-killed deer with 14,394 during 1964, followed by Wisconsin with 8,107.

Both the reported and estimated deer kills are undoubtedly far below the actual loss. Many deer are hit by vehicles on the highways but not killed outright, escaping into nearby areas where they die from injuries but are not found.

Many states are experimenting with devices and other means of reducing vehicle collisions on highways.

Almost all states use deer crossing signs to warn motorists of danger areas; the problem is to convince motorists that they should slow down in game areas and be on the alert for deer crossing the highways.
