

## IMPROPER CLASSIFICATION DISCUSSED

Improper archer classification has again b en brought before the VBA Board of Directors.

Several instances occurred at the State Shoot in which archers obviously were improperly classified according to their ability. As a result, they were reclassified upward by the Executive Committee.

All clubs are again warned that they must assume their responsibility for classi-

fication of their members; otherwise, the Executive Committee will take action to advance, at any time, (including during conduct of the State Shoot), any archer found to be shooting in the wrong class.

All clubs should also note, it was decided that, if any three or more members register with VBA a complaint of improper classification of an archer, action will be taken to correct the situation.

# AUGUSTA ARCHERS GAIN BID FOR 21st STATE SHOOT

The Augusta Archers, of Staunton, have been awarded the bid for the 21st Annual VBA State Championship.

The Staunton club will also have a 2-year option on the annual event to be held September 3 and 4 of this year.

The Augusta Archers last held the shoot in 1964 and promise for this year such things as; three 28-target courses, a large cinder block club house to be used for registration and entertainment, ample parking area, spacious camping area, water on range, 14 practice targets, and motels and restaurants within short distances of range.

There were two bids submitted this year. Sherwood Archers, Roanoke, being the other. A tie vote resulted when the Board of Directors were balloted. A flip of a coin decided for Augusta.

Augusta will be the first club that could take advantage of the 2-year option. At the discretion of the Board of Directors, the host club can conduct the shoot for two years in succession.

Reasoning on this is that a club realizes such a small profit from the shoot, on a one-time basis, they are reluctant to tackle the job and all the back-breaking work that goes with it.

However, if the club should host the shoot the second year, the pro rata cost of materials would be lower and labor would be minimized.

# WARDEN'S WORK IS NEVER DONE

During 1965, Virginia's 129-man fish and game warden force put in 356,299 manhours of law enforcement work, covering over 3 million miles by road and 92,000 miles by water in performance of their duties.

They checked the equivalent of about half of the licensed hunters and fishermen in the state and over half of the registered boat owners.

They apprehended 6,810 persons for violations of the game fish and boating laws, of which 6,340 were convicted. Trespass was the most common cause for ar-

We can also offer competition to anyone desiring it as evidenced by our four 1966 National champs, and we can offer a mixture of competitive shooting, non-competitive shooting and hunting practice, as well as other interesting subjects, all in one two-day shoot, through our Bowhunters Jamboree.

Regardless of all of the gains that were made during 1966, there is still progress to be made on the national level which will benefit all archers. As the old saying goes, there is strength in numbers. In our particular case the greater number of members in VBA, the greater our voting strength at the national level. With this thought in mind, I challenge each of you through your individual and combined efforts to end the year 1967 with the largest, strongest and most progressive VBA since its inception.

## AMATEUR COMPETITION COMMENTS ARCHER

The following is a letter from Tim Daley, an archer very much interested in amateur competition.

In the National Field Archery Tournament, Virginia had six shooters registered as amateur, and in the State shoot, only one was registered as amateur. Our records indicate that there are only three declared amateurs in the V.B.A. Out of the 1225 members in the V.B.A., I am quite sure there are more than three that do not want to classify themselves as professionals.

Why, then, aren't there more amateurs? There could be various reasons why: one, lack of knowledge or the awareness that the amateur status exists in archery, two, possibly there is no incentive (why should an archer compete for a piece of paper when his buddy is competing for a trophy), or three, he doesn't really care. The latter could be quite dangerous if the archer does possess the skill that would enable him to be eligible for the Olympics.

I feel that we should have the Amateur as well as the Professional. This makes room for *ALL* those interested in the sport. To have both the State and local organizations should recognize both, not by thought or word but through suitable awards as well. You, as an individual, should signify which you wish to represent.

I am currently holding the title of V.B.A. Amateur Champion, a title I am quite sure should belong to someone else with more ability, especially since I am only a "B" shooter. I am looking forward to the 1967 V.B.A. State Championship Tournament where I hope to find a lot of competition to defend my title.

rests in the 2,626 convictions for game law violations followed by hunting without a license and hunting during the closed seasons. Of 2,864 convictions for fish law violations, well over half were arraigned for fishing without a license. Equipment violations accounted for the majority of boating law convictions.

### WYTHEVILLE OPENS

### INDOOR SEASON

The Wythe Bowhunters of Wythoville, Va. opened the winter indoor archery season Sat., Nov. 19th. Ninety-eight archers took the line, firing for that perfect 300 in the Freeman Round.

The states of North Carolina, West Virginia, Tennessee, and Virginia were well represented by their state champions. High scores were captured by Virginians' James Mitchell with a 294, Phil Tillison 293, and B. C. Atwell 292.

Most of the other class winners were determined by counting the 5's and 4's as ties developed in about all classes.

Our youth really turned out for this shoot with 19 competing. Young Butch Burchette, Freestyle, took top honors with a 289, followed by Ronald Weddle, Instinctive with a 279, and Jeff Stanley, Freestyle, with a 275.

The ladies were well represented with high scores as follows; Penny Shannon 273, Virginia Dillow 268, mother and daughter, Mary Shaw 265, of North Carolina. The Wythe Bowhunters schedule is Jan. 14, Feb. 11-12 a 20 yd. Flint, and March 11 a 20 yd. walk up. We are in hopes to have as good a turn out for each shoot as the first and play host to as many champions.
