# **Changes In Classification**

Directors from the various clubs spent at the VBA meeting held in Lynchburg on January 5th. Various numerical changes were discussed along with proposals to change the names of the different classes. It was finally decided that inasmuch as the reorganizational meeting of NFAA would be held in February, that due to this reorganization it is very likely that all States will have the same classification system and that this standard classification system may not be the same as ours, it would be very unwise to completely change ours at this time and then maybe have to change it again in less than a year. With these thoughts in mind, the Directors present voted to make only two changes in the instinctive division and to break freestyle down into three classes. These changes are as follows:

- 1. A class to be known as "AA" was added for men shooting 450 and up.
- 2. A class to be known as "AA" was added for women shooting 350 and up.
- 3. Men's Class E was changed from 0 to 174, to 100 to 174. In other words, there is no class for persons shooting less than 100 in men's instinctive.
- 4. Women's Class E was changed from 0 to 124, to 75 to 124. In other words, there is no class for persons shooting less than 75 in women's instinctive.

Archers who had two or more "AA" scores on his or her 1963 classification card are now classified as "AA" and should have their 1964 classification card marked accordingly.

The following classes were added to the men's and women's freestyle divisions:

No changes were made in our Youth Division which is still in a probationary status. Changes in up and downgrading in classifi-

cation were as follows: An archer is raised to the next higher class

scores above his present class. This to occur in a 12-month period. An archer, at his own option, can advance to the next higher class after shooting one score above his present class.

An archer is eligible for downgrading after failing to shoot his class in any calendar year.

In order to be downgraded in class, an archer must first present his case to his local club for approval. If his club approves his application, his club secretary should forward same to the office of Field Vice President for processing. Full details as to reason for downgrading should be given. The mere fact that application was made will not guarantee that an archer will be downgraded but each case will be judged on its merits.

Any archer who failed to shoot his class during all of 1963 is now eligible for downgrading.

At the option of the host club sponsoring a VBA sanctioned tournament, a special group or division can be made available for archers who desire to shoot noncompetitively. This group will be called the "Non-Competitive Group." They will be governed by the following rules:

- 1. Same tournament procedures as for other divisions.
- 2. Will shoot same rounds.
- 3. All archers shall be eligible to participate-no class distinction.
- 4. Official tournament scores recorded as for other divisions.
- 5. This is a non-competitive group.

#### **Classifying Freestyle Archers**

Any archer who was shooting freestyle in 1963 and wishes to shoot it in 1964 should check his classification card for the two highest scores shot last year. If they are both within one of the classes listed above, then that is his class. However, if one of the scores is in one class and one in another, then his correct class will be the lower of the two. The reason for this is that, effective this year, an archer needs two scores within a class to be upgraded. Any archer may take the option of advancing himself on shooting the first score above his class.

### ANIMAL ROUND

For quite some time now the animal round has been the subject of controversy at VBA meetings. It has been felt by some that this round, as presently set up and scored, is a "Sandbagger's paradise," inasmuch as it is possible to hold back on the hunter and field round scores and "burn up" the animal targets thereby winning a tournament without advancing in class.

In an effort to bring the animal round scores down on a more or less even plane with the hunter and field round scores, the President appointed a committee to study the problem and give a report on their findings.

Norman Ashburn, Chairman of the Animal Round Committee, has submitted the following:

"On October 6, 1963, the Chesapeake Bowmen Archery Club held a modified animal round on our range during a VBA tournament.

"The following rules were observed:

- 1. Each archer shot four (4) arrows at each target, two (2) arrows from the closest stake and two (2) arrows from the next closer stake. On all single staked targets, four (4) arrows were shot from the single position.
- 2. Each arrow scoring a hit in the vital area was scored five (5) points, each arrow in the other part of the animal scored three (3) points.

"The Committee recommends that this modified round be tried by other clubs in the State for a period of one (1) year and all scores be compiled and evaluated for the purpose of future classification and as a preventive action against sandbagging."

Since the animal round is, and always has been, a more or less novelty round in that scores are not entered on classification cards, clubs are urged to try this method of shooting and scoring. When sending in animal round scores, club secretaries should indicate on their tournament report form that this new scoring and shooting system was used.

As a matter of information, the tournament report forms are sent to Field Vice President W. T. Marshall, 5012 Huntington Ave., Newport News, Va., who will in turn forward the new animal round scores to the Animal Round Committee for evaluation.

# **TOURNAMENT REPORTS**

Some secretaries made the job of Field Vice President unnecessarily hard in the last half of 1963 by being too lax in sending in their tournament reports. As a reminder, T-1 and T-2 forms should be turned in for all shoots and should be received in my office within a week from the date of the shoot. This includes club shoots. These reports should actually be mailed no later than the first Tuesday following the shoot. Continued laxness on the part of some secretaries may result in the loss of a sanctioned tournament. This is a step I would certainly hate to take, but it is necessary that these reports be in on time in order for me to keep the records of this office up to date. This is a tough job and can be handled correctly and efficiently only with the cooperation of the club secretaries. I know I can depend on you.
