I have received the agenda items for the 1996 NFAA Annual Meeting and will have them ready for discussion at the January VBA meeting. Since the NFAA annual meeting will be held at Myrtle Beach this year, and several VBA members have expressed interest in attending, it might be beneficial for them to have following information:

The general session will be called to order at 10:00 a.m. on February 14, 1996. At this time there is the usual call to order, invocation, pledge of allegiance to the flag, roll call, introduction of guests, special announcements, etc.

Some of the Rules of Assembly that may be of interest are:

1. Guests must be seated in the visitors' gallery. They will not be recognized unless such request is made of the Chair by a Committee Chairman or a Director. A guest is considered to be someone other than a Director, Councilperson, Committee Chairman or Officer of the NFAA.

2. Guests are not allowed in Committee meetings unless invited by the Committee Chairman. They should be invited to leave the room before any vote is taken on an item of business. (I

believe most Chairmen would not object to having a guest present.)

3. As a representative of Virginia, I am scheduled to be on the Equipment Committee which will be chaired by our Mid-Atlantic Councilman, Mike LePera.

Sherwood's Jamboree A Rewarding Success

National Bowhunting and Archery Day was celebrated at Sherwood Archers in the form of a Jamboree. We held the Jamboree on September 23 and 24 and enjoyed the company of 133 visitors to our club. Many of these were non-members and they came from all over. Some were from out of state!

The event was advertised on TV and in newspapers and magazines. Everyone was invited - from the Novice to the Seasoned Archer. All events were free. Our guests were given a brief tour, some safety rules and a list of events. They were allowed to shoot 3-D, animal and field targets. We even had a short range of broad-head mats.

Inside we had a mini-museum of the history of archery and some artifacts. Information and displays were available about VBA, NFAA, IBO, Izaak Walton and Department of Game and

Inland Fisheries. Videotapes were played throughout the weekend on various subjects, from bowtuning to the latest hunting techniques.

Many of our visitors enjoyed free lessons in archery. A Girl Scout troop that came in early Saturday caught the "archery bug" and plan to return in the spring to earn their badges. Some of the guests were having problems with their bows and really

appreciated the help and instruction they received.

All food served was graciously donated by our members. Most of the printing for flyers and advertising was donated. Door prizes were either donated or left over from previous events. We had to do a lot of planning and a lot of work, but we were able to keep our expenses to a minimum.

We know that our guests enjoyed themselves - they said so! But what was so great is that we did, too. It was so much fun to see all of them coming and going with smiles - the children and adults shooting for the first time and loving it. It was surprising how many people did not even know we existed and came not knowing anything about archery, but they left knowing something and wanting to know more. Camouflage for Hunters

I could feel my heart pounding in my throat as the doe feeding under my tree stand lifted her head in my direction. She seemed to stare right through me. Seconds later she twitched her tail, lowered her head and began to feed once again. Though she had spotted me, my human form had been broken by my camouflage. Long ago I realized the value of large patterned camo versus small when deer hunting from a tree stand. Many camouflage clothing manufacturers advertise by showing pictures of hunters in a tree which has foliage, blending in very well with their surroundings. Nevertheless, this is where I have a problem. Most hunters continue hunting during late fall and winter from their tree stands when trees no longer have leaves. The camouflage that once hid a hunter so well now gives his presence away easily. The hunter becomes a "Big Blob" as a result of his silhouette.

Chances are very good that the animal will see the hunter long before the hunter locates his quarry. To be a successful hunter, especially a bowhunter, you need to have a camouflage pattern that works for, and not against you.

Camouflage clothing is comparable to automobiles - everybody prefers a different brand or style, although only a few are effective. I break camouflage down into two categories. The first pattern is basically pleasing to the human eye but is actually worthless as camouflage. This pattern utilizes small bark and leaf designs integrated with a dark background, which looks great very close. Now place a hunter in a tree stand, move away from the tree to where the animal

would be seen. Those small bark and leaf patterns disappear almost every time and turn into one dark color, allowing you to be silhouetted against the sky. The best camouflage clothing incorporates a light colored background with a large dark branch pattern. The branches are actually three shades, giving a three dimensional effect and breaking up a silhouette very effectively. Two companies have accomplished this very well.

The first camouflage on the market to use a tree branch pattern was Greg Haskell's Skyline. This pattern was revolutionary at hiding a tree stand hunter's silhouette after the leaves

have fallen. It is also amazing in snow - you virtually disappear. Skyline Camo has also developed a three-dimensional camouflage with nine separate colors with broken patches that represent treetops, branches, leaves, bark and shadows to blend in any terrain in tree stands or on the ground. Skyline calls it the "Ultimate" and "Ultimate Green-leaf" for turkey hunters or early season bow hunters.

Another very effective pattern, and one that I would highly recommend is ASAT Camo by Brigade Quartermasters. This pattern is one of my favorites. ASAT stands for All-Season All-Terrain. As the name implies, this

pattern blends excellently in any terrain and any season of the year. There is no need to change from one hunt to another. A hunter has many options and can even choose an oversized lightweight outfit to wear over heavy clothes, or use alone for warmer weather.

Webster's Dictionary defines camouflage as "A means of concealment of persons or material, especially one that makes them appear to be part of the natural surroundings."

Tree stand hunters striving to virtually disappear in pursuit of their quarry are well advised to look into these superior designs. If not available at your local dealer, call the following for more information:

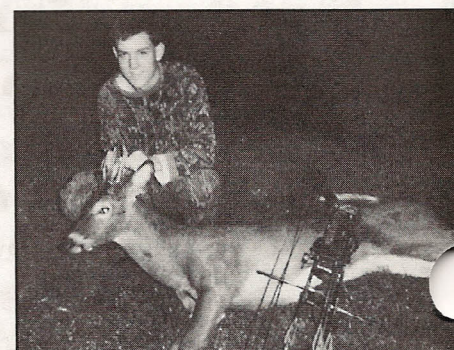
