From the President

This is the time for bowhunters. This is also time for anti-hunters. Those of you who are graduates of the International Bowhunter Education Program (IBEP) learned about ways to deal with our critics. But perhaps the one thing we can all do is not to provide anti-hunters with the ammunition they can use against us. That means carrying out our own responsibilities to the game we hunt, to the landowners who give us their permission, and to the game laws of Virginia. Nothing threatens our hunting privileges more than the slob who others mistakenly call hunters. If you are interested in a program for your club meetings on this topic of hunting versus anti-hunting, call the game commission and order the film "A Question of Hunting" from their film library.

This is the time for indoor shooting, or soon will be. The months between the outdoor tournament season can be put to good use by participating in the many indoor leagues, and tournaments offered all over the state. I missed the fun last year and plan to fix that this year. The State Indoor Championships will be hosted by Kingsboro Bowmen in March of 1987, and looks like it will be every bit as good as the fine work that Triangle Archers has done in past years.

This is the time for nominations for VBA Officers. At the September meeting a VBA nominating committee was named with C. D. Miller as chairman (Wythe Bowhunters), and Mickey Baugh (Buggs Island Archers) and Earl McAuley (Massanutten Archers) as members. The committee is to report back to your directors at the January meeting so that the nominations can be printed in FLIGHT before the March meeting when the floor will be open for further nominations. I have told the nominating committee that I will not be running for office again. I feel that four years with the same president is enough and it is time to change.
