Proposed Dues Increase

Over the past few years the work load has been gradually building up in various offices of VBA, particularly the offices of Corresponding Secretary, Field Vice President, and Recording Secretary, the former being underpaid and the latter two receiving no pay. In short, we are asking these three individuals to do too much work for little or no compensation. This is an unreasonable request to make of these VBA officers who are donating their time and energies freely to the furtherance of our great sport.

In view of the foregoing situation, a committee headed by former Corresponding Secretary Edna Gillespie, was appointed by President Limerick to make a detailed study of the situation and furnish the Board of Directors with a report and recommendation.

The investigation by this committee revealed that there has been some duplication of work between the offices of Recording Secretary, Field Vice President, and Corresponding Secretary, and their recommendation is that we form an office of Paid Secretary to replace the office of Corresponding Secretary, increase the pay for this office from the present 40¢ per individual VBA member, to \$1.00 per individual VBA member, and have the Paid Secretary take down and type up minutes of VBA meetings, which work is presently being performed by the Recording Secretary, and enter and record tournament scores, which work is presently being performed by the Field Vice President.

With this additional work added to the Corresponding Secretary's (proposed Paid Secretary) job, it will require roughly eight hours per day to perform the duties of this office. I realize there are many VBA members who wonder what work is performed in the Secretary's office that could possibly take that much time. As a matter of information, and so that you will know what you are getting for your money, below is a partial list of the duties of this office and the approximate time it takes to perform some of them:

Collect, record, and deposit all VBA money.

Process memberships—this includes making the plate used in the Addressograph for new members or when a change of address occurs.

Process "20" Pin applications, and order "20" Pins from our supplier.

Process VBA Patch orders.

Mimeograph Minutes, assemble and mail.

Mimeograph forms and keep clubs supplied.

Prepare FLIGHT for bulk mailing and carry to post office.

Take care of most letter correspondence.

Mimeograph ballots and prepare for bulk mailing; carry to post office.

Order stationery and keep adequate supplies on hand.

Prepare Quarterly Reports.

Help new clubs prepare for affiliation. Issue Club Charters and Renewals.

Keep the Executive Committee informed at all times of important business correspondence.

Time Involved at Present:

Routine work requires about 3 hours per

Additional time as follows:

FLIGHT: 9 hours each time.

Ballots: at least 24 hours.

Minutes: 24 hours.

Rush of incoming memberships in January and February adds several hours per day.

Possible Added Duties:

Take minutes at meetings.

Record scores from T-2 forms—approximately 1½ hours per day.

Process orders for Jewelry (if we decide to sell this type of thing).

Increased correspondence when NFAA reorganization goes through.

You can see from the foregoing that this is a full-time job with part-time pay. In addition to the approximately eight hours per day of work that we will be requiring of the Paid Secretary for the \$1.00 per year per individual that VBA proposes to pay this officer, we are also renting office space equivalent to a room with a minimum size of 12' x 12'. It is necessary that this room be well lighted and comfortable and given over entirely to VBA. From this you can see that this is largely a "labor of love."

An increase in dues was recommended back in 1959 by one of our forward-looking members, a former Treasurer of VBA, and a Certified Public Accountant, Al Lipske. However, at that time, we did not heed Al's expert advice. He said that we should immediately increase VBA dues by a minimum of 50¢ per member in order to maintain a cash reserve which is needed by an expanding organization such as ours.

Obviously, we cannot continue to ask these three VBA officers to do this enormous amount of work on their own time and at their own expense. Therefore, all clubs should thoroughly discuss this moderate, belated, proposed dues increase and have their director prepared to express their club's opinion and come to some decision at our next quarterly VBA meeting which will be held on October 11.

So much for the local side of the matter.

As you all know, on the national level, at the recent reorganizational meeting of the National Field Archery Association which was held in Chicago, Virginia was represented by Martin Smith and Ted Grefe. As a result of this meeting, the NFAA will be reorganized

as an association of States similar to the way Virginia is organized as an association of clubs. In order to organize the States along this pattern, all present State members of the archery association will automatically become NFAA members with NFAA dues being paid by the State association. Because of this expected tremendous increase in NFAA membership, it will make possible the reduction of NFAA dues from \$2.75 per year to \$1.00 per year.

I believe that most all archers whether they are interested in tournaments or hunting, or both, if they do not presently belong to NFAA, have always wanted to in order to be eligible for the NFAA 20-pin and bars, Art Young large and small game awards, Order of the Bone Award and Fellowship of Robin Hood Award, in addition to the fact that by being a member of NFAA, they strengthen the sport of archery as a whole. Many persons, even though they really wanted to belong, simply have not taken the trouble to send their membership dues to NFAA, or some few felt they couldn't afford the \$2.75 per year dues.

We all know there is strength in numbers, and if archery is to continue to grow, it is necessary that we unite ourselves so that we are all pulling in the same direction.

In view of the above, it will be necessary that VBA dues be increased accordingly.

Augusta Archers Are Active

Things are humming at the Augusta Archers' range and are scheduled to continue throughout the summer months in order to make comfortable and entertain the heavy crowd expected at the State Shoot.

On our work party schedule, between now and you know when, we anticipate painting the building, clearing more picnic area, decorating, installing new score boards, and inside rest rooms.

Bar-B-Q chicken will be served by the Ruritan Club on Sunday. We plan to sell hamburgers and hot dogs throughout both days. Breakfast will also be served both days . . . on the range.

For the campers, periodic deliveries of ice and milk are planned

Safety First

This is not only bad publicity for archery in general but it is a threat to the safety of others. Individual clubs are charged with the responsibility of policing this matter and if anyone attempts to enter competition while in obviously no condition to do so, he should be escorted from the range.

Scheduling Session

Attention Secretaries

Effective immediately you may discontinue preparing tournament report Form T-1. Tournament report Form T-2 should still be prepared, however, it will not be necessary to put down either the aggregate score or animal round scores.

Some secretaries are still not using the four digit number that appears on an individual's classification card, when preparing Form T-2. Also, some secretaries are using nicknames. It is important when filling in Form T-2 to report an archer's name and number exactly as it appears on his classification card. This enables the Field Vice President to enter the archer's score on the proper card. This information is very important in case of a lost classification card because with this information the Field Vice President can prepare a duplicate card showing correct tournament dates and scores.

SAVE MONEY ON OTHER ARCHERY TACKLE AT HITE'S ARCHERY

90-Day Rule

In order to be eligible to compete in the State Shoot, all archers must have shot in at least three tournaments within the 90-day period prior to the State Shoot, in which an official 28-target hunter or field round was shot. Either sanctioned shoots or club shoots will be acceptable and if two official hunter or field rounds are shot in one day on the same range, they will be counted as two qualifying rounds.

Listed below are five possible ways to comply with the 90-day rule:

- One tournament in June, one in July and one in August.
- 2. One in June and two in August.
- 3. Two in July and one in August.
- 4. One in July and two in August.
- 5. Three in August.

Any VBA member, adult or youth, can shoot in the State Shoot but in order to shoot competitively, he must comply with the above minimum requirements.

In other words, must an archer continue shooting regardless of the weather in order to win? Are archers who stop shooting automatically disqualified? Will you do what the majority wishes in case of bad weather? Put it down in writing and everyone will know. It may save some hurt feelings.
