YOUTH PROGRAM

The Youth Program as outlined in the last issue of FLIGHT was discussed for quite some time both pro and con at the last VBA meeting. It was generally agreed that the program and its intent were good and after discussing it item by item, the following evolved:

1. There shall be established a Youth Division consisting of all VBA members under 18 years of age, whose membership fee shall be \$1.00.
2. All youths under 18 years of age will compete as amateurs until their 18th birthday or until they marry.
3. The Beginners Training Program will be incorporated in the Youth Program.
4. After completing the Beginners Training Program, he will then compete, unclassified, in a V.B.A.-sanctioned tournament in the Youth Division. At his first tournament in the Youth Division, he will be classified under the Youth Program consisting of classes A, B, C, D, E, and F and Free Style, as presently established for adult men and women. He will be classified upon completion of the first 28 target classifying round.
5. V.B.A. twenty pins only will be awarded in the Youth Division because they will be shooting from the adult stakes. (If the youth qualifies under N.F.A.A. rules for NFAA 20 pins, it shall be awarded.)
6. Competitors in the Youth Division shall shoot from the adult stakes.
7. The pin awarded to the Youth Division shall be a suitable pin and shall maintain the same basic colors as the adult Instinctive Division.
8. All youths shall be grouped together insofar as is possible.
9. Free-style shall be governed as the Adult Free-Style Division.
10. The Youth Program shall be adopted for a one-year probational period.
11. This program will become effective July 1, 1963.

90-DAY RULE

I am sure most of you are familiar with the 90-day rule which is Article 29 of Tournament Procedure, reading as follows:

"A classified archer must compete in a minimum of three tournaments within a 90-day period prior to the V.B.A. State Championship Tournament. No more than one of the three may be shot in a 30-day period, except all three may be shot in the last thirty days. Should an archer have a valid reason for not complying with the above, he may appeal to the Field Vice President for waiver of this rule."

This rule was put into effect some years ago when archers were advanced in class by taking the average of their three highest scores out of the last four tournaments shot. An archer could shoot a couple of high scores and then a low one to pull his average down and in this manner keep from advancing in class. The idea has been kicked around that under the present system of advancing in class if you shoot one point out of your class into the next higher class, the 90-day rule is no longer needed. On the other hand, it would be feasible for a person to shoot in the State Shoot this year in class "E", practice diligently for 12 months without attending a tournament, enter the State Shoot next year in class "E" and win class "A".

This rule was made expressly to eliminate "Sandbagging." The question now is whether this rule should be eliminated or modified to conform better with our present method of advancing in class. Kick it around at your next club meeting and send your director to the next V.B.A. meeting prepared to express your feelings as to what should be done.

Spring Gobbler Season

For you archers who would like a little spring hunting, the spring gobbler season opens April 29th through May 4th. Shooting hours are from one-half hour before sunrise until 10 o'clock each morning. You must hunt by calling and shoot BEARDED turkey only. Hunting these grand old birds is perfectly legal with the bow during this season.

Good News—30-Day Hunting Season For 1963

At the Commission meeting March 29th, our request was again presented for a 30-day season for deer, bear, and squirrel. We have been informed by Commissioner A. Ree Ellis of the 7th District, that we will have a 30-day archery season, October 15th through November 15th, both dates inclusive.

Final count on hunter success for the past season was 81 applications for deer and one application for bear. This was considerably below last season and as much as I would like to believe it could be blamed on the weather, food, and poor shooting of some of us archers, the truth is, most of the western county deer herds have leveled off at about what the browse in the area will support. We must accept the fact that this saturation point is inevitable. Increasing kills, year after year, cannot be made as in the past, with the present browse.

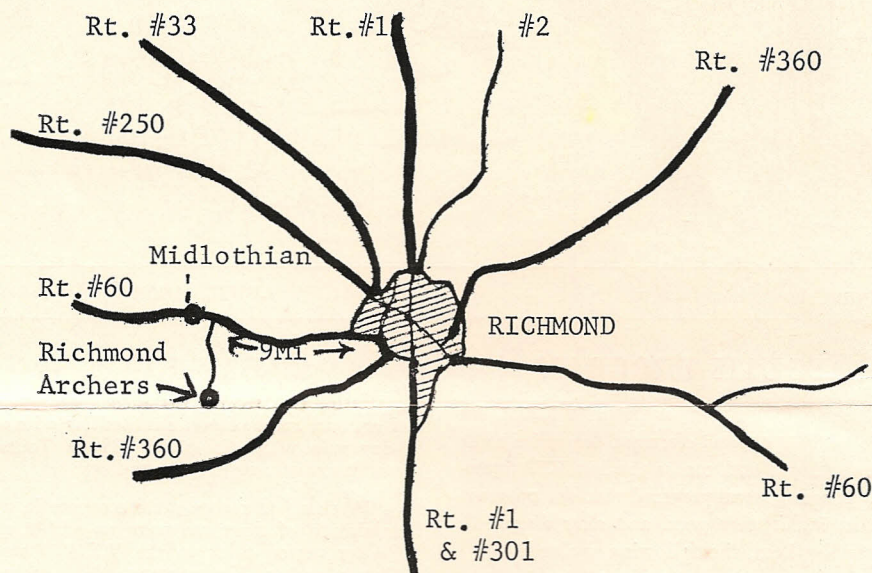

VOTE

Within the near future, you will receive a ballot in the mail covering election of VBA officers for the new year beginning July 1, 1963. Last year, out of some 1,800 members, only about 500 took the trouble to vote. You may say, "Why vote? There are only two offices with more than one candidate." The only reason this condition exists is that the various clubs failed to have their voting director who attends VBA meetings nominate anyone for these offices. I feel that we have a very good slate of nominees for the coming year and hope that everyone will exercise their voting right.

In the past, some members have included other correspondence in the envelope with their ballot. This should not be done. These ballot envelopes will not be opened until the June VBA meeting and any correspondence that should happen to be in an envelope slows up the persons who are counting ballots.

One person, Gertrude Lewis, has asked that her name be withdrawn as a candidate for the office of Treasurer. This leaves C. D. Tarter and Hazel Rogers as candidates for that office, and Vernon Rogers and Clinton Western as candidates for the office of Executive Vice President. In case you may not know any of these nominees, a brief outline of their qualifications is set forth below to guide you in your voting:

Treasurer—Hazel Rogers—An active member in both the Warwick Bowmen and Bowmen of York clubs. Has been club secretary for two years and club corresponding secretary for two years. Active in promoting fellowship throughout the state. Has been an account clerk for the City of Newport News for 10 years.

Treasurer—C. D. Tarter—A native of Wythe County. Has been interested in and has taken an active part in archery for the past seven or eight years. One of the original 13 charter members of Wythe Bowhunters. During the years 1959-60-61 served as Secretary-Treasurer for Wythe Bowhunters. Presently Secretary-Treasurer of Tarter Chevrolet, Inc., Wytheville.

C. D. has always taken an active part in working with youth, serving as a coach for sandlot football and basketball teams and as advisor to Explorer Post 60 of the Boy Scouts of America. Frequently serves as a Sunday school teacher.

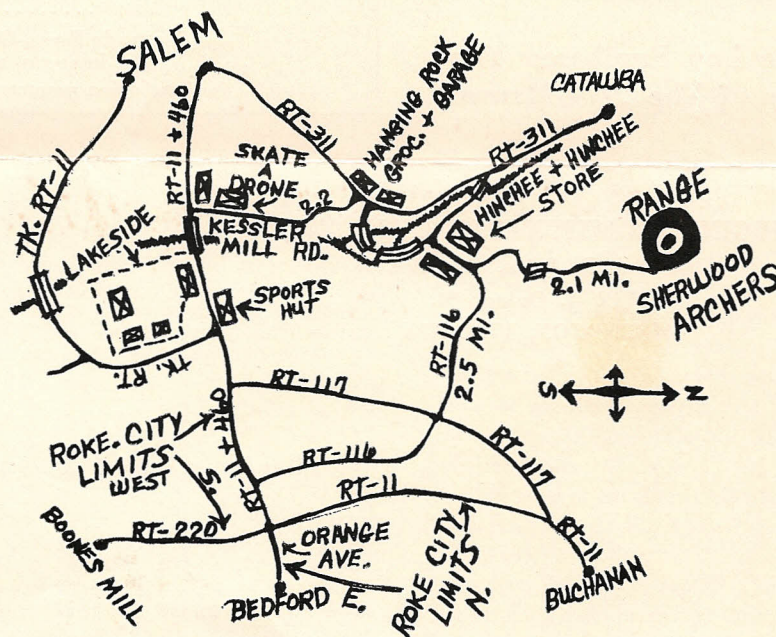
Bill Bennett Big Game Awards

Classification Card Numbers

If you will look at your classification card, you will notice two numbers. One of these numbers is preceded by a letter. This is the club number (example, A-24 is Sherwood Archers) and is used by the corresponding secretary. The other number is the individual's number. It has been requested by Field Vice President Marshall that club secretaries use this individual's number on Form T-2 in the left margin next to their name. This will help eliminate any possible mixup in names and insure having the right score posted on the right card in the Field Vice President's records.

Your cooperation will be appreciated very much by the Field Vice President.

CONSERVATION
