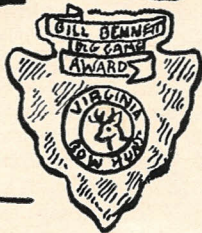

## From the Field Vice-President to Club Sec't

Since the outgoing club secretaries do not always pass on to the new secretary all the information necessary to properly perform all the duties of that office, some of the more important duties are listed below, which will assist the club secretaries in doing their job as well as others who depend on them for certain information.

### 1. Forms T-1 and T-2—Tournament Reports.

(a) Fill in these forms completely, all names should be as shown on the archer's classification card. Please do not use nick-names.

(b) Mail these forms within one week after any tournament (includes club shoots) to the Field Vice President.

(c) If your scheduled tournament consists of a novelty shoot or any type shoot other than a 28 field and/or a 28 Hunters round, notify the Field Vice President.

(d) When an archer advances to a higher class he stays in that class for the remainder of that year plus the next full calendar year. An archer does not drop to a lower class simply because he fails to shoot his class score.

(e) An archer entering a tournament for the first time is an unclassified archer and should be entered as such. When filing in the T-2 form under the column marked "class" enter the archer as unclassified, then in the column marked "class if changed" enter the proper class designation according to the score shot in that tournament. This determines the class in which he enters at his next tournament.

(f) If 28 field and 28 Hunters rounds are shot during the same tournament, the highest score of either round determines an archer class.

(g) An archer who enters a tournament without his classification card may shoot non-competitively only. If

## Statistics On The 1961 Hunting Season

To date there has been 108 applications returned. Three of these for bear kills, 58 for doe and 47 for buck deer. All but 4 of the above were taken during the October season. There were 25 kills made on opening day and Saturday, Oct. 28, was the next best day with 13 kills. The most successful hours were between 5 and 6 p.m. with 26 kills or between 7 and 8 a.m. with 13 kills. Only 1 deer was taken during the noon hour.

There were 128 hits for the 108 kills, so most of the successful hunters made one-shot kills. Average distance of the shot was 30 yds., as against an average of 31½ yds. last year. Last year the successful hunter averaged tracking his deer 116 yds.; this year he averaged 172 yds. Longest successful shot was an 84 yard one by Eugene Limerick.

Of the deer actually weighed—the average was 110 lbs. against 103 lbs. last year. Largest was a 14 point buck by C. D. Tarter which weighed, hog dressed, 256 lbs.

Fifty-nine of the successful hunters made their 1st. V.B.A. kills and 49 were successful for the 2nd. or more times. One man, Vic Peyton, was successful in bagging both a bear and deer on opening day. Archie Gordon and Walter Kello reported their 7th. V. B. A. successful season.

The average archer used a 45 lb. bow, and 78 used wood arrows, glass arrows accounted for 20, and aluminum for 4. Fifty-two hunters used Razorheads, 14 Black-Diamond, 9 Bolow, and 7 Herters.

Augusta Archers lead the clubs with 14, Bridgewater Bowmen second with 9, Senedo Archers 7, and Warwick 6.

There are several more applications out, and I feel sure we will surpass the 119 reported last year.

- a member of your club has lost his classification card, you as the secretary, should write to the Field Vice President for a duplicate card.
2. Forms and application blanks and Pins.
    - (a) Obtain all VBA forms and application blanks from the VBA Secretary, Mrs. Sue Price, 1712 North Quincy Street, Arlington 7, Va.
    - (b) Obtain VBA 20 Pins—same as above.
    - (c) Obtain VBA Tournament Pins from the Field Vice President.
    - (d) For information on range approval write to the NFAA Field Governor for Virginia, Mr. F. M. (Ike) Lewis, Route 2, Box 190, Portsmouth, Va.
    - (e) Application for club affiliation and application for club charter should be filled in and mailed to the VBA Secretary the first of each year. Form #2 club roster of paid VBA members should be complete with full names and addresses of all members and indicate if these are new members or renewals.
    - (f) Old members who change their home address please note both the new and old address. This eliminates a great deal of research and duplication of effort.
    - (g) Furnish age and date of birth of all junior and intermediate members.
    - (h) If your range is NFAA approved be sure to register all shoots for the NFAA "20" Pin. As soon as you receive the Tournament Schedule suggest you register all of your shoots at one time (include your club shoots if desired).

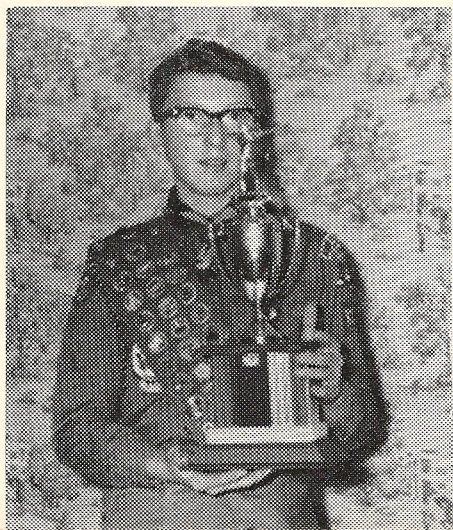

## Hold Trophy Banquet

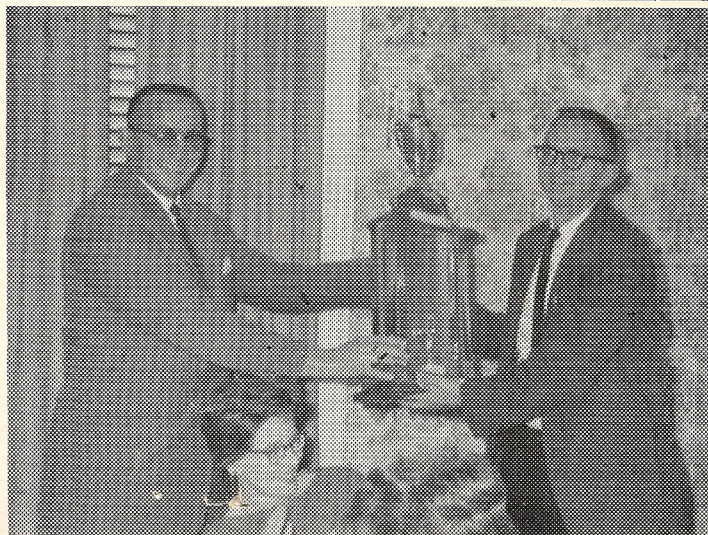
At last year's March meeting, the Wythe Bowhunters of Wytheville, Virginia, voted on and passed an amendment to their constitution setting up an annual banquet at which a large doe and an outstanding buck trophy would be awarded to one of the members. It was further decided that there would be a "Ladies Night" with the idea of better acquainting the members' wives with the aims and fellowship of the club that are experienced by the members.

On Dec. 14th, 1961, the Wythe Bowhunters First Annual Trophy Banquet was held and it was the unanimous opinion of those present that a good time was had by all. Door prizes were awarded to the ladies present, items of interest to archers, with the hope of perhaps causing some members' wives to take active participation in the sport of archery.

The Toastmaster for the evening reviewed for the members and also the ladies the progress that the club has made in the short time it has been in existence. It was brought out that the club has approximately 60 very active members and in our opinion the finest course in the state. The Wythe Bowhunters were very active in promoting and starting an archery club in Galax, Va., now known as the Galax Bowhunters. The Wythe Club is extremely happy that they now number 90 strong.

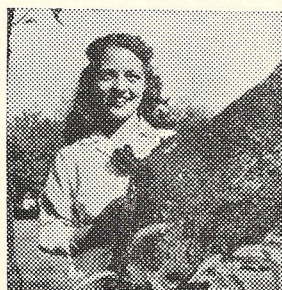

1. Contest is open to all male archers 16 years of age and above in the State of Virginia.
2. Entry will be a fee of \$2.00 for any person who is a member of an archery club. The entry fee for a non-club member will be \$2.50.
3. All applications for entry must be turned in with entry fee to club secretary on or before the 1st. of March, 1962. Non club members will turn in applications and entry fee to club sect. of club whose range they wish to use for qualifying.
4. Applications may be obtained from **Flight** magazine, club sec. or local sporting goods store or by writing direct to, The Sport's Hut, 1535 East Main St., Salem Va.
5. The contest will be held on a basis of six classes, a-b-c-d-e- and open. Open class is for non club members who have not as yet established their class.
6. All entries will have from March

1st. to April 15th. to shoot their qualifying score on their home ranges at their own convenience. The qualifying round must be shot with a minimum of 3 other entries (in same class if possible.) Score cards must be signed by 2 of their shooting partners and turned in to their club sec. before or by April 15.

7. All entries will shoot a standard 28 target field round.
8. The winners of the six classes from each club will compete in a sectional tournament to decide the finalists who will then compete in the final tournament to be held in Roanoke at the Sherwood Archers range.
9. Club winners will be notified by mail as to time and place sectional tournaments will be held.
10. There will be a standard tournament charge of \$1.50 at the sectionals and finals.
11. All entries will compete in the class shown on their V.B.A. cards and will remain in that class throughout the contest regardless of scores shot.
12. The six finalists will leave from the Sports Hut on Saturday, June 2.
13. For the clubs that do not have an

A class or Open class entry, the entries in the D & E classes with the second highest scores can be substituted. These men would still shoot in their regular classes throughout the contest. This would enable each club to have six finalists in the sectionals.

With a great deal of smiling from two members and crocodile tears from the other hunters present, the purpose of the meeting was fulfilled (see picture).

Mr. C. D. Tarter of Wytheville was awarded the large buck trophy for his kill of a real "trophy deer." His buck

weighed 205 lbs. field dressed and had 14 points accruing a total of approximately 146 Boone and Crockett points—quite a kill for an excellent Virginia hunter.

It was the total feeling of all club members that the presentation of the trophy for the largest doe killed was one of great satisfaction. This trophy was given to John Price Newberry, a young

fourteen-year-old archer of Bland, Va., who has been very active in attending the shoots in Southwest, Va., and who participated in the State Shoot at Fort Eustice. John's doe checked in at 113 pounds.

Several "Big Liar" awards were given but it is deemed prudent at this time not to disclose any of these names.
