



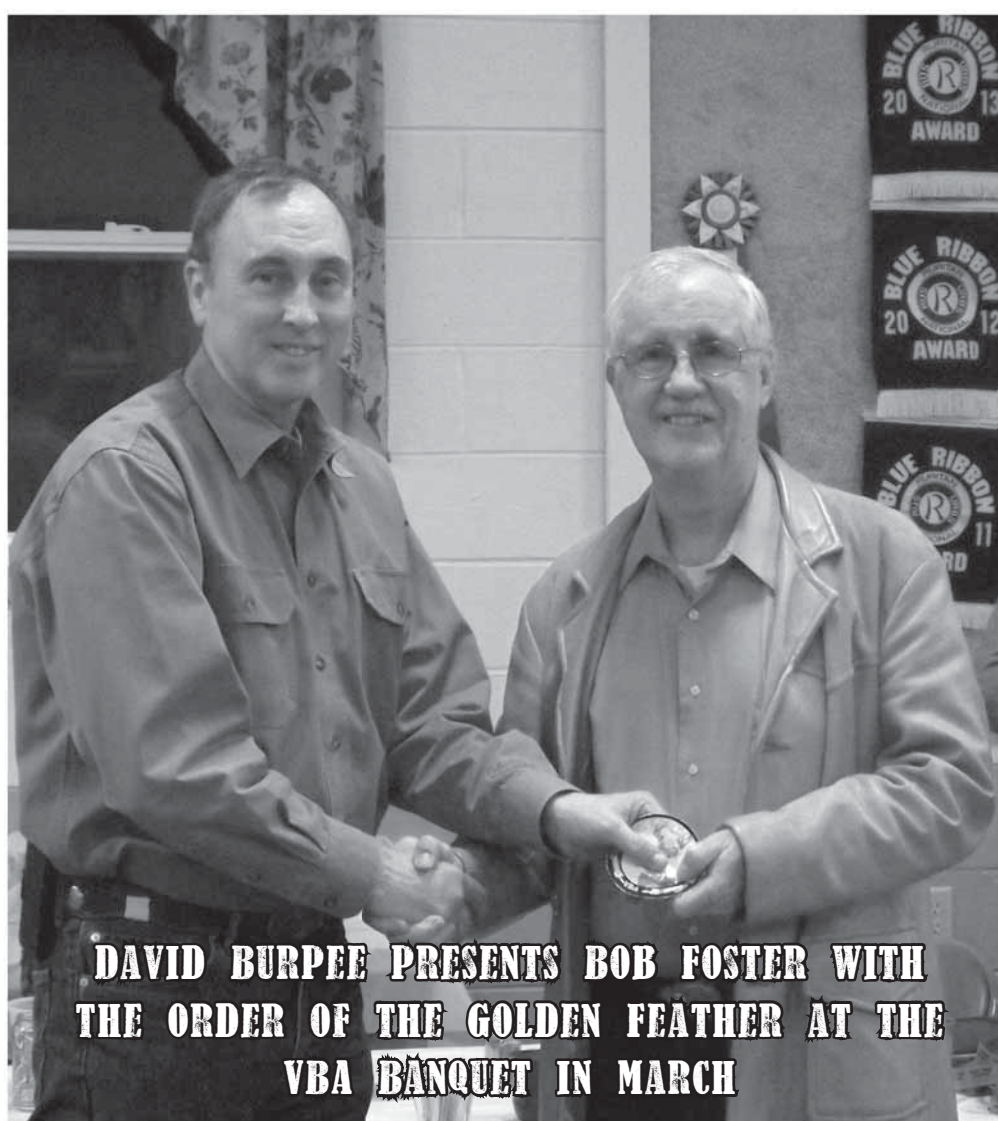

Everyone enjoyed listening to our guest speaker, Eric Brittle, Fisheries Biologist from Region 4 (East) Fredericksburg. Eric gave a very nice presentation on Deer Management control and environment on the property that his family owns.

There were no Triple Slam awardees, but 40 archers received the Bill Bennett Big Game pins.

The Does by Weight were: Hunter Havener, 1st place @ 133 lbs., BOR; Terry Dorman, 2nd place @ 112 lbs., and Charlie Wright, 3rd place @ 100 lbs.

Bears Dressed by Weight were: Bakari Dale, 1st place @248 lbs., BBH; Dana Colton, 2nd place @ 127lbs., Massanutten and Clint Keller, 3rd place @ 122 lbs., Massanutten.

The Turkeys by Live Weight were: Kayla Layton, 1st place @ 17.6 lbs.; and Hunter Havener, 2nd place @ 10 lbs., BOR.

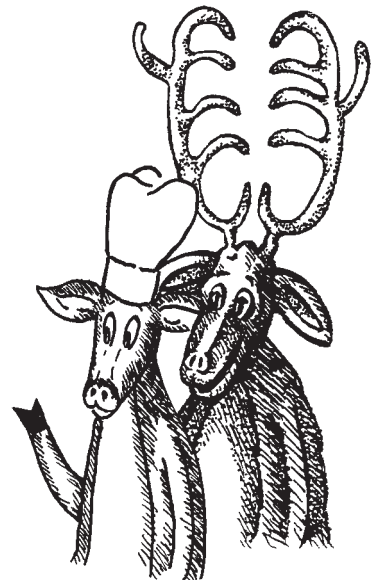

WALLY'S CAJUN BUCK ROAST

1/2 cup chopped onion
1/2 cup chopped celery
1/4 tsp black pepper
1/4 tsp cayenne pepper
1/4 tsp white pepper
2 TBSP oil
2 cloves garlic minced
1 rump roast
3 slices of bacon

Preheat oven to 300 degrees, mix onion celery, oil, mustard, and seasonings in a bowl. Make slits in the roast, fill the slits with the mixture of veggies and spices you have mixed together and rubbing the rest on top of the roast and then place the bacon on top of the roast. Cook for 90 minutes or until done.

We had an outstanding awards presentation consisting of 13 first time Bill Bennett awards and 5 Double Slam Awards. There were 53 total awards given between 7 clubs. We had a great raffle and silent auction and I believe that everyone had a great time. We had just over 70 attendees with about 8 youths attending as well. It was a great pleasure to see the kids, our future, attending the banquet. We fellowshiped, we ate a great meal prepared by the Keezletown Ruritans. We were also entertained and educated about managing deer in a pressured environment by Eric Brittle who is a fisheries biologist with the DGIF. My only wishes during the event were that more of the VBA membership could be there to enjoy the night with us. I hope in the future that more of you can attend.

If you do not already know consider yourselves notified, 2016 will be the VBA's 75th anniversary. We plan to have an even bigger and more fantastic Banquet next year. Look for the date to be announced soon and make plans to attend.

I want to take the time here to thank all of the businesses, clubs and individuals that donated items for the raffles and silent auctions. They are greatly appreciated and help to fund future banquets. The VBA sends a special thank you to Bass Pro Shops, Bryansteen's Guns & Archery, Steve's Archery & Guns and Wilcox Bait & Tackle.

Now for the rest of the news, Cay McManus and I attended the DGIF Board meeting on March 17, 2015 at Blacksburg VA. There were many topics brought up both good and bad. I spoke to the Board on behalf of the VBA concerning several new proposed regulations that will affect the coming hunting seasons. The first is the expansion of youth bear days proposed for the second Saturday of October to possibly include Sunday. This will include dog hunting for bear in counties that allow dog hunting. The VBA is against any further encroachment to the Archery season. We as bowhunters have had to continually sacrifice our season for other hunting groups. The DGIF does not encroach on general firearm or muzzleloader season. The second is to expand the youth bear weekend in September to include both Saturday and Sunday and allow dogs for bear. The third is expanding the Youth Turkey day on the 3rd Saturday of October to a Youth Turkey weekend on the 3rd weekend of October. Once again the VBA is against this action. The fourth is a proposal to ban all lure and attractants that are made from cervids (deer, elk...). These are just a few of the proposals that can and will affect our archery season if we do nothing. I ask all VBA members to organize against these proposal. Take the time to contact the DGIF board. You can call them, email them or comment on the DGIF website. You can even attend one of the informational meetings and speak your mind. If you have friends or family that are bowhunters ask them to speak against these proposals. The bottom line is we cannot sit idly by and expect the DGIF Board to look after our best interest. We need to be active and fight for what little we have. The minutes from the DGIF Board meeting will be available soon and the comment period will begin April 4th.

AGENDA ITEMS

Agenda Item at March Meeting:

(1) Add to Shooting Styles, pg. 10 of 23, Art. 13, pg. 12 of 13, Sect. G: Traditional Release, same as G-add use of release and string loop-use of stabilizer, 12" max, would change #2 and #4.2 classes only, men and women, 1st, 2nd, and 3rd ,no division breakdown. **Failed**, 28 no,10 yes.

Agenda Items for June Meeting:

(1) Add a new paragraph to the By-laws, Sect. 15.1.1., pg. 11 of 23, State Indoors as follows: E. In case of weather interfering with shooting dates and times, a host club shall have the following option: Be allowed two weeks to make up any cancelled rounds due to cancellation caused by inclement weather or other occurrences. The timetable for make up within the two week period would be at the discretion and/or ability of the host club to do so. Effective, Jan.1, 2016.

Justification: This would allow more archers to shoot and those that missed, to get in their rounds and more time to get all the information correct, before sending out awards.

(2) Section 15.1.10 Registration Fees, pg.13 of 23: Registration fees for the State Open, Closed, and Indoor Tournaments shall be \$20.00 each for the first two adult archers, \$5.00 each for the first two youth (under 18) archers, with a maximum of \$50.00 per family. Change first two adult archers to first two family members. Effective, Jan. 1, 2016.

Justification: Family member discount not a discount for young archers, same as 3-D tournament fee. Cost of awards for youth more than cost of registration.

From the NBEF/IBEP Director

The first chapter of the IBEP Manual, “Modern Bowhunter”, is an introduction to our history of modern bowhunting. I usually supplement the teaching material by with facts and historical dates that I’ve picked up over the years. It is usually a guessing game, with even the old timers correctly guessing only a very few. So how is your historical knowledge of our sport? Care to try your luck on the 10 questions below? Each question is worth 10 points, and bonus questions are worth 5. See if you can get a passing score of 80 out of 125 possible points! Answers are shown on a later page in Flight.

1. Who is credited with the first patent on his invention of the Compound Bow? Bonus Point: What year was the patent awarded?
2. This state is credited with granting the first designated bow hunting season in the USA. Bonus Point: What year was it?
3. In what year did Henry Bitzenburger invent his famous “Bitzenburger” fletching jig?
4. This archer is credited with beginning the mass production of Archery beginning in March of 1938. His company may have been the largest manufacturer of archery equipment between 1939 and 1967- which (at periods) during that time frame employed around 800 employees. He was among the first inductees of the Archery Hall Of Fame in 1972. Who was he?
5. This renowned bowhunter designed and sold the first working recurve bow. Who was he? Bonus Point: What year did this occur?
6. Which archery company first introduced ‘Torque Stabilizers’? (Hint: They are very much still in business and introducing new products!) Bonus Point: What year did this occur?
7. In what year did Easton first trademarked aluminum arrows? Bonus Point: What was the name of the arrow line?
8. Max Hamilton introduced ‘Plastiflech’ vanes to replace feathers. What year was it?
9. Warner Brothers Pictures hired this famous bow hunter and shooting exhibitionist to coach Errol Flynn to perform as a convincing archer in his role as ‘Robin Hood’ in the movie.
10. In what year did “Cams” first appear on compound bows? Hint: It was the same year that 3-D Archery was introduced.

Answers:

1. Answer: Holless Wilbur Allen. Bonus Point: His patent was granted in 1969, although he is said to have actually designed it 3 to 4 years earlier. Mr. Allen was a keen bowhunter who was disappointed with the slow speed of hunting bows used at the time, so he decided to design a new type of bow for hunting. His original design had ‘wheels’ that were triangular shaped.
2. Answer: If you guessed the “Badger State” of Wisconsin, give yourself 10 points! Add 5 Bonus Points if you correctly guess 1934 as the year for our first designated archery season.
3. Answer: The “Bitzenburger” fletching jig has been a benchmark for generations of archers! I still own and use one to fletch my arrows. Henry invented it in 1941.
4. Answer: If you guessed Fred Bear, you would be wrong. It was Ben Person. My first bow was a Ben Person “Colt” bought at my local hardware store in 1968. I still have it and shoot it.
5. Answer: If you guessed Fred Bear again, this time you get 10 points! Bonus Points awarded if you correctly put the year at 1953.
6. Answer: Everyone shooting a Hoyt stand up and cheer for the right answer - Hoyt Archery Company. Bonus Points awarded if you put the year at 1961.
7. Answer: 1946. James Easton actually started experimenting with making aluminum arrows back in 1939, but it took him a few years to get the manufacturing process down. But when he did, he started a whole new era of shooting! Bonus Points awarded if you correctly indicated the arrow line was the “24 SRT-X”.
8. Answer: 1951. Surprised? Plastic fletching has been around a long time. It wasn’t nearly as flexible or durable as today’s versions, but it was a start, and an option to feather fletching.
9. Answer: The one, the only, Howard Hill. Long bow shooter extraordinaire! If you ever get a chance to watch some of the few films of his exhibitions, you will see one of the finest instinctive shooters of our time. He was a true Phenom!
10. Answer: 1982. Or that’s what my source says. But I watched Jim Cox (Owner and Operator of the Elkhorn Archery Shop, Salinas, CA) shoot a traditional bow with the end of the bottom limb sawed off and a cam eccentric mounted in its place on the Salinas Bowmen Archery Range back around 1980. So in a spirit of generosity, I’ll give you 10 points for 1982 or 1980!

The Difference Between A Food Plot and A Deer Feeder

My home state of Georgia (Go Dawgs!) has recently experienced a clash of cultures in the Georgia General Assembly between deer hunters who want to legalize deer hunting over bait versus deer hunters who want to keep it illegal to deer hunt over bait. The Georgia Department of Natural Resources (GADNR) has opposed deer hunting over bait for years for many very good reasons. Since I have been an outspoken opponent of deer hunting over bait in the past, my Bulldog friends and colleagues have kept me

abreast of the ongoing deer bait debate in the popular media in Georgia. The best anti-baiting shot, in my opinion, was fired by Glen Dowling, executive vice president of the Georgia Wildlife Federation in an Atlanta Journal Constitution editorial that was published February 23, 2006 on page A15. It is listed below and used with the permission of the author. It is excellent.

Deer hunters shouldn't get unfair edge. To hunt -- as defined by Webster's 7th Collegiate Dictionary -- is "to traverse in quest of prey." If some South

Georgia legislators have their way, deer hunters will have to do little more than sit back and wait for the prey to find them.

These legislators want to pit the non-hunting community against the hunters. How? By allowing hunters to become simply killers by legalizing shooting over bait. Forget that the wildlife -- including every whitetail deer in Georgia -- belongs to all Georgians. South Georgia legislators argue for legalizing killing deer over bait because there are too many deer, hunters are impatient and their marksmanship is poor. These legislators seem to want hunters to be able to lure unsuspecting deer to within a few yards of the front porch of the hunting cabin in order to kill.

Supporters of House Bill 1285 claim it is "value added." This isn't the value of ethics, patience or hunter education. Value to them is selling corn, selling feeders and ultimately selling hunts to the wealthy, who "do not have the time to hunt."

As President Theodore Roosevelt wrote in Principles of the Hunt, "The rich . . . who are content to buy what they have not the skill to get by their own exertions, these are the real enemies of game."

In South Carolina, shooting over bait in the southern coastal plain is legal. In that same area, natural deer behavior has been altered. Their natural ranges and movements have diminished, and the animals have become more nocturnal. The result is lower hunter success and a higher deer-vehicle collision rate. In the upland of South Carolina, where shooting over bait is illegal, hunters enjoy a higher rate of success and motorists are not threatened by an increased deer population on the road.

It is currently legal to supply supplemental feed to deer. However, if

hunters are allowed to shoot over bait, the experience of other states demonstrates that food will be supplied at an exponential rate. Such practices expose deer and agricultural herds to an increased potential of disease. The corn sold to hunters is often labeled "not for human consumption/do not feed to livestock." Yet lazy, greedy hunters and those out for a quick buck deem it acceptable to feed such corn to wildlife.

In addition, by providing a bait site, hunters create an unnatural predation area where coyotes kill young fawns and other unsuspecting wildlife.

The most unfortunate result of legalizing baiting is that it will dumb down generations of hunters so they'll simply watch a bait site like a television screen or video game. Just tear open a bag of corn, pour it out and, with a brain in neutral, stare at it.

Let's keep high the ethics and standards of hunting: safety, fair chase, sportsmanship, stewardship of natural resources, outdoor skills, the lesson and virtue of patience, the experience of scouting and the wisdom of knowing when and when not to shoot. Don't let others steal our hunting heritage and tradition. Don't take the bait.

I consider myself lucky to live and work in Virginia where deer hunting over bait is illegal and a deer hunter survey collected by the Virginia Deer Hunters Association in 2003 clearly indicates that a strong

majority of Virginia deer hunters oppose deer hunting over bait (81%).

One of the Georgia baiting proponents' main arguments for allowing deer hunting over bait in Georgia is that deer hunting over bait is allowed in many surrounding states, including Florida, North Carolina, and South Carolina.

Again, I am lucky to live, work, and deer hunt in Virginia. The argument that everyone else is

doing it, so we should too, would never fly in Virginia. When I was a teenager, my father used to call this logic monkey see - monkey do!

The Georgia baiting proponents' argument that I found the most interesting and entertaining is that deer hunting over deer feeders and bait is no different than deer hunting over a deer food plot. They pointed out with a passion that private landowners and the GADNR routinely plant and allow deer hunting over deer food plots. Like many

deer management professionals, I have heard deer baiting proponents make this "food plots equal baiting" argument for decades, but I have also heard this point discredited.

At the 1993 Southeast Deer Study Group Meeting in Jackson, Mississippi, there was an open debate over deer baiting. Many of the Southeastern deer biologists in attendance were against hunting deer over bait, especially those from states where it is illegal, and many were for deer hunting over bait, especially those from states where it is legal and common. Of course, one of the baiting proponents stood up and played the food plot card. Dr. Harry Jacobsen of Mississippi State University trumped it. Dr. Jacobsen noted that he had planted and recommended food plots for decades but he had never established one that could train or teach the deer when to appear like a deer feeder can. I think the baiting proponent quickly sat down. What was Dr. Jacobsen talking about? With a deer feeder you can train a white-tailed deer to tell time and teach them appear on demand. Does this constitute fair chase? Of course not.

This unfair feeder and bait advantage was first engraved in my memory by a fellow Georgia wildlife

biologist who told me a story about when he was trapping deer with a rocket net as a graduate student. The person who let him off at the trapping site told him to be ready to fire the net at 3:15. He gave them a puzzled look, but they just told him to be ready at 3:15. The site as he described it was a big thick cutover next to an old dairy barn and silo with the net set in a small clearing. Like any good graduate student, he did what he was told. He sat there and nearly froze to death constantly looking at his watch. No deer were anywhere to be seen. Then about 3:15 he heard an awful groaning sound (the screw auger turning food out of the silo and down the feed trough). By the time he finally figured out what the sound was, he noticed movement in the woods. As he described it, the cut over was crawling with deer headed toward the feed. He caught deer at 3:15!

This feeder advantage was reinforced several years ago by a deer hunting friend of mine who went out to a private property in Virginia, where the owner had been feeding deer for years. They were standing on a deck looking at a feeder in a food plot several hundred yards away when the landowner looked

down at his watch and said, "Watch this." The feeder went off on time and half a dozen to a dozen deer magically appeared in minutes. Yes, with a feeder you can teach deer to tell time and be on time.

Over the years, I have met many deer hunters who hunted deer out west at commercial deer hunting operations, mostly in Texas. They were put on a stand overlooking a feeder and told to wait for the feeder to go off, seen the deer magically appear, and then killed one. In their defense, most don't want to go back. I have seen one writer describe shooting deer that are standing under a feeder as "meat hunting". He noted that he did not see much sport to it, but admitted that it was a fast and easy way to put venison in the freezer. On the bright side, if you just happen to be a deer hunter who does not like to get up early, you could set the feeder for let's say noon and sleep in. The result would probably be the same. In fact, after I completed the first draft of this article, I was reading another article where the author called these feeders Texas Deer Calls.


Don't get me wrong. I am not writing this article to defend deer food plots. In fact, I should note I am

not a proponent of deer food plots. In my nearly 14 years in Virginia, I do not believe I have ever recommended a private landowner put in a food plot for deer management purposes. If I have, it was a mistake. I have, however, on numerous occasions, recommended to landowners when and what to plant (e.g., a cool season annual and white {ladino} clover) when it was obvious they were going to plant something for deer no matter what I said.

I personally do not know what sound a deer feeder makes when it goes off. I have seen them in the stores and catalogs, but I have never actually used one or heard one. I do know that they can be set to go off at a specific time. I assume the sound they make is sort of a whirling sound. The effect is similar to rattling a handful of corn in a five gallon plastic bucket. I should note that the sound of a handful of corn in a plastic bucket at my house will bring in my daughter's miniature horse and the cows on a dead run!

I know this sound works on deer because over the years, I have been told dozens of stories about this "magic." Anyone who has ever looked in a hunting catalog has seen the gadget they sell that makes the sound of a deer feeder going off. It is not a feeder; it just makes the magic feeder sound. The sound is the stimulus that results in the response -- the deer showing up on time looking for the corn which is the reward. They teach this Pavlov's dog conditioning in high school Psychology because it works.

When I can look in an outdoors catalog and see a gadget for sale that makes the sound of a deer food plot going off, and someone can show me how it works, or if I actually see it work, then I will agree with the deer baiting proponents that food plots are no different than deer feeders and deer hunting over bait.

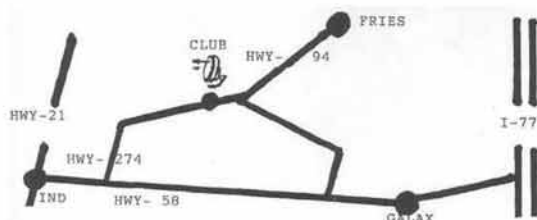

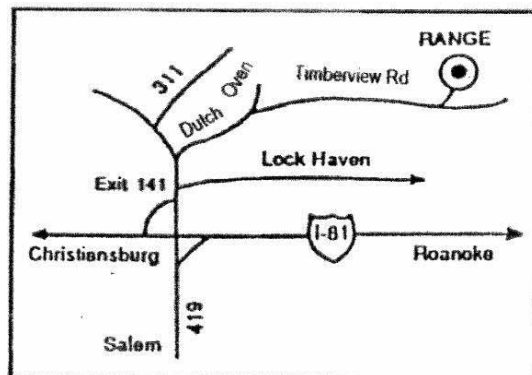

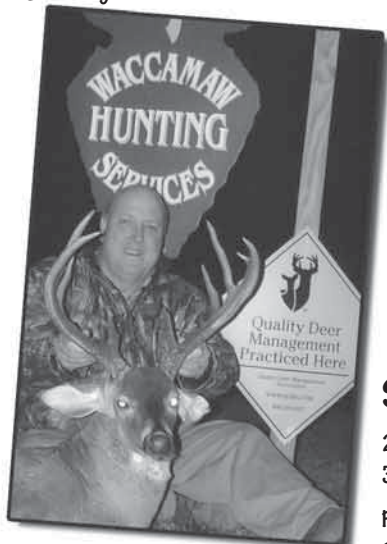

Conservation Scholarship

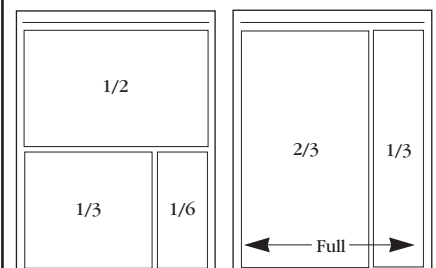

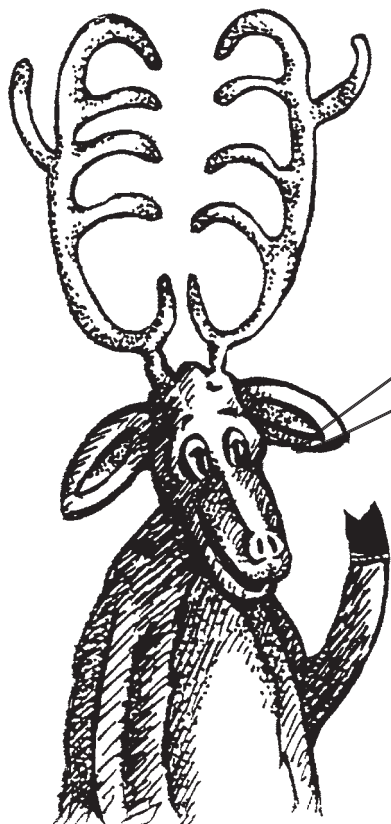

NOMINATIONS DUE IN MARCH

The VBA Order of the Golden Feather was created to honor those persons who have given unselfishly of their time and talents toward the betterment of archery and archers. Recipients are persons who possess the virtues of sportsmanship, character, morals, integrity and friendship. As a reflection of the substance for membership, only 80 people have been elected to the Order in the past 71 years.

To be qualified, a candidate must be member in good standing of the VBA at the time of nomination, must have a minimum of ten successive years' membership in the VBA and must be sponsored by three VBA members of good standing or by a VBA Club.

This article is a reminder that candidates must be submitted to the Board of Directors at the March meeting for this year. Nominations must be in writing and be signed by sponsoring individuals or a Club officer. Successful nominees have always performed duties or had an impact outside their immediate club.
