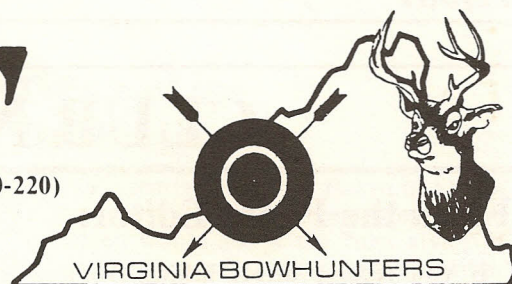

Our Voice Will Be Heard

Since June 1989, when I took the job of Virginia's NFAA Director, I have logged more time on the phone than I would have thought possible. Seldom does a night go by that I'm not on the phone to Nancy Lee, Clinton, other State Associations Directors, Councilmen, or NFAA Officers. When I'm not conducting business on the phone, I'm writing letters soliciting support, or opinions or questioning the actions of NFAA Officers and Councilmen.

VBA's role in the NFAA has helped shape the NFAA of today. This shaping needs to continue and with the help and support of you the VBA member, I foresee Virginia playing an even greater role in this shaping process.

Last year the VBA was 3rd out of the 50 states in total NFAA membership. This translates into 3 votes at the NFAA annual meeting. In order to reach that magical number of 4 votes, our NFAA membership in Virginia would have to hit 1500. Our strength lies in numbers.

Whenever an issue arises that concerns the way we do business in Virginia, the VBA has an obligation to its members to be heard. The more votes we have, the louder the voice. NFAA President John Slack has heard our voice and has labeled us "untouchable." To anyone in a position to dictate policy to our VBA organization, I hope we stay untouchable.

The annual NFAA meeting in 1990 is fast approaching. There are already issues that need addressed. Some have to deal with membership, while others deal with the sovereignty of our State Association. I've already made VBA's position known to NFAA on these issues and others. Through letter writing campaigns, and personal contact with other State Directors, I hope to sway enough Directors to stand with Virginia on these issues. There are smaller State Associations who look towards the larger State Associations for leadership and guidance. It's up to me with your help to provide this.

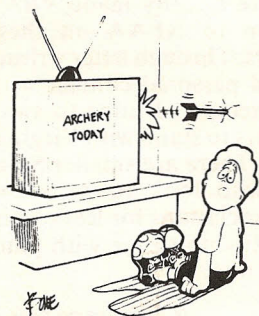

The next quarterly Virginia Bowhunters meeting will be held on January 13-14, 1990 in Charlottesville, Va.

Agenda items are:

1. (Cay MaManus) I would like to make a motion that at the NFAA Sectional and National levels, the unit role be dropped. The top 3 places should be awarded and/or acknowledged in all divisions. There is too much time and money spent just getting to these shoots for archers not to be acknowledged.
2. (Princess Anne/Kingsboro) a. Each director return to the January 1990 VBA meeting with monetary contributions and/or advertising for "new style *Flight*," if possible. (Goal of \$120 per club) b. Each director return to January '90 meeting with their clubs means of providing *Flight* editor with printed contributions, if possible.

As one of the main duties of my office is to publish six times yearly our publication *Flight*, I would like to share my feelings regarding the much discussed issue of the "new style *Flight*," as it has come to be labeled. (See magazine form/July-Aug. 1989)

Presently before the Board of Directors is the agenda item listed above which would adopt the "new style," if passed, funded by monetary contributions and/or advertising to help pay for such a publication. This could be putting a possible hardship on many clubs that may not have the funds to contribute. You currently pay \$2.00 from your VBA dues now as annual subscription price for *Flight*.

My concern is simply this—is such a fancy magazine really a necessary thing? Are there not many ways of improving our "old style" as the second part of the agenda item suggests and doing it at a reasonable cost?

Just because we may receive money from the clubs does not necessarily mean *Flight* will be better regardless of its format. NO publication can be successfully produced without help from everyone. A magazine form of *Flight* will be no more informative than our present style until WE ALL start contributing more information and stories to it.

While records may not be completely accurate, we know that Ted was a member of VBA and NORVA as far back as 1957. The length of Ted's service is not as important as the quality of his service. He, along with other members of VBA, was instrumental in reorganizing NFAA along what became known as the Virginia Plan.

Ted's larger than average stature and his booming voice commanded attention, and his quick mind and analytical abilities enabled him to cut right to the core of most problems. Even though he had not been visibly active in recent years insofar as VBA is concerned, it was the foregoing

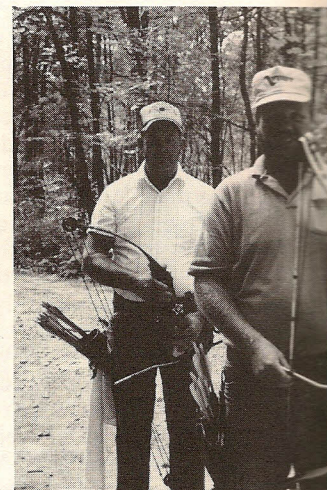
qualities that caused me, as well as others, to seek his advice on matters pertaining to archery. I, in fact, discussed some matters with him within the last four months.

Our most sincere sympathy is extended to Ted's wife, June, son Dusty, daughters Caroline and Laurie, and other family members.

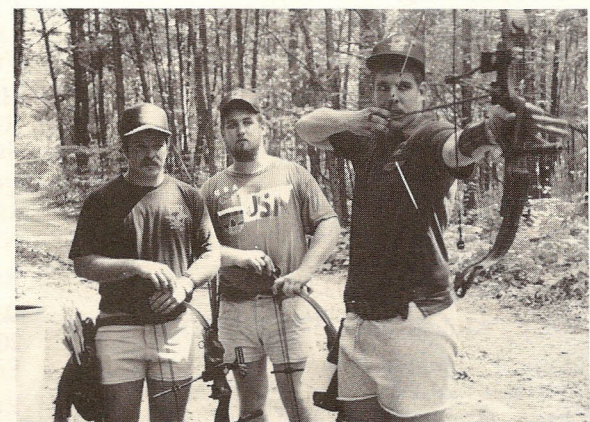
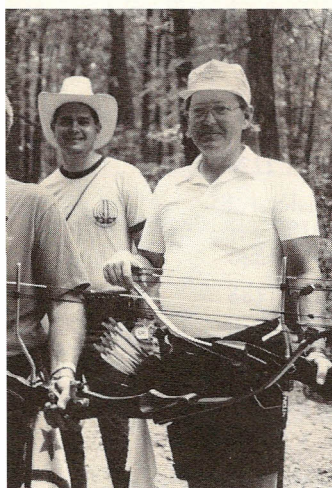
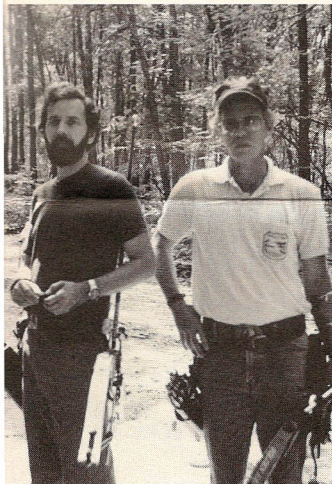
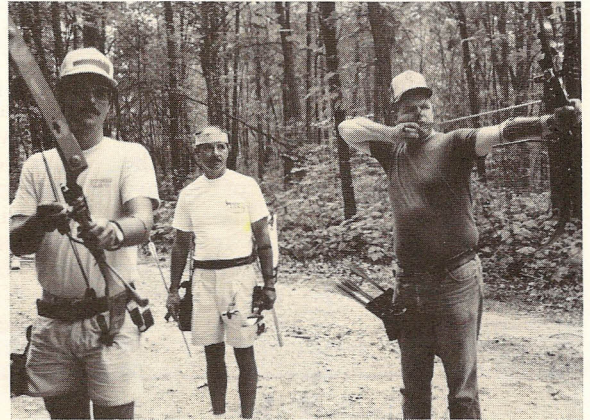
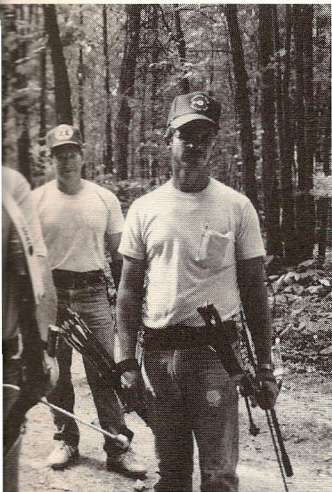
