

NOTES FROM THE V.B.A. MEETING V.B.A. SAYS "NO WAY"

The V.B.A. delegates voted that, in the event that N.F.A.A. notified V.B.A. that they would adopt the new A.A.C. rules, the N.F.A.A. delegate is instructed to inform N.F.A.A. the V.B.A. will not comply.

The following club delegates who attended the meeting voted unanimously for the above action: Augusta Archers, Bowmen of York, Cub Run Archers, Northern Va. Archers, Princess Anne Bowmen, Sherwood Archers, Warwick Bowmen, Wythe Bowhunters, Lunga Archers, Loudoun Bowhunters, and Little Mtn. Archers.

It is further noted that Chattanooga rules will prevail. In other words, the same rules we have been using will continue. This, of course, allows releases and the compound bow in Free Style. Bare Bow is the same. A clicker is allowed as long as it does not protrude above the arrow. Refer to the April issue of Archery for exact particulars. (Ed. note -- It is not clear that V.B.A. has been notified of the A.A.C. adoption. However, Ralph Stevens, N.F.A.A. Director; has written N.F.A.A. President Wingfield that we will not comply. One serious consequence in the event we are dropped by N.F.A.A. (this probably won't happen) is that all Virginia


archery clubs would lose their N.F.A.A. insurance. continued page 2-


