OFFICE OF THE FIELD GOVERNOR

Due to an article in the October-November issue of Flight, there has been wild confusion over the Bowhunter Division. The article stated "that the men use an 11/32 shaft with a 125 grain point, and the women use an 5/16 shaft with 100 grain point. This statement is wrong, and I feel that the archers of the state are due an apology. I APOLOGIZE.

The original meaning of the article was not that a bowhunter use a certain type shaft. As a matter of fact it is spelled out very plainly that any type shaft can be used as long as you use 125 grain field point for men, and 100 grain field point for women with adaptor for broadheads, where needed.

I am further clarifying the statement to read:

1. A 125 grain 21/64 or 11/32 I.D. field point for men with appropriate adaptor for the shaft you use, to convert to broadhead.
2. A 100 grain 5/16 I.D. field point for women, with appropriate adaptor for the shaft you use, to convert to broadhead.
3. This may change with the N.F.A.A. meeting in 1968, but until then, I feel that this is the solution to keeping uniform in the State. I feel this will change no one's shooting equipment because most bowhunters are using the proper equipment now. It will give the new bowhunters division entrants a guide to go by when changing over. I hope this has clarified a very bad mistake, and we can all go on to good shooting this year.

**FROM THE CORRESPONDING
SECRETARY'S OFFICE**

Don't embarrass the tournament secretary of a host club by attempting to register for a sanctioned shoot without your 1968 classification card, or without having paid your 1968 NFAA and VBA dues. This is in accordance with NFAA rules. (See Article XI, Paragraph C 3, page 26 of the NFAA handbook.)

The new VBA manuals are now available through your club secretary or through this office at 50¢ each. This manual contains the VBA Constitution and By-Laws, rules governing the Order of the Golden Feather, sanctioned tournament schedule for the entire year 1968, and up-to-date information on each VBA club, such as range location, and club secretaries.

Since it is dues time again, and all of you will be contacting your club secretaries, there are a few things that everyone should know which will aid your local secretary and me in processing your 1968 application for membership. I will give you the good news first. We now have a VBA family membership which is \$10.00 maximum. This became effective January 1, 1968. Also, remember the NFAA family membership is \$3.00 maximum.


Listed below is some of the information your secretary will need in order to handle your application for membership efficiently:

1. Give your name exactly as it appears on your previous membership card.

2. Make sure your secretary has your correct address, including ZIP CODE. If your address should change at any time during the year, please report it promptly.
3. Each member has a permanent VBA number, the four digit number on his classification card. In order to maintain correct records, such as 20-pins, big game awards, etc., it is very important that no old member be assigned a new number, which could happen if his name is reported differently when dues are sent in for the new year. Therefore,

members moving to a new locality and joining a new club should give their new secretary their name exactly as it appears on their old classification card, and tell the new secretary that they have previously belonged to VBA.

4. Give month, day and year of birth if you are under 18 years of age.


