Attached is a recommendation from the President of Virginia's NFAA affiliate, the Virginia Bowhunters Association, for the NFAA Medal of Merit for Mrs. Nancy Lee Western. I strongly support his recommendation and would like to add some observations of my own.

## Special Effort Made to Bring Archery to the Law Enforcement Olympics

While attending a meeting of my archery club in November (Northern Virginia Archers or NORVA) I put before the group the idea of having a special archery tournament for police. It was discussed and several points were brought out.

1. If the tournament went well Mr. Thomas Franke, the regional director of the Law Enforcement Olympics (LEO),

would consider adding archery as a field event in the Law Enforcement Olympics in the 1987 games. This alone would be a big plus to archery as a sport nationwide.

2. This could lead to the building of the general strength of archery clubs across the state with more competition and better public relations between the police and public.

Mrs. Western has probably contributed more to the sport of field archery than any other individual Virginian.

She has held the office of Corresponding Secretary for our state organization for nearly 20 years. She also attends State level tournaments to offer her assistance. She has traveled thousands of miles attending these and other archery functions.

Mrs. Western is respected throughout the State by all who deal with her, State level officers, club officers, and individual NFAA members. She not only never refuses to respond to a request for information or assistance, she does so with patience and understanding. Her selfless service to the sport of field archery has earned her Virginia's highest honorary award—The Order of The Golden Feather.

Mrs. Western's archery activities have not been limited to administrative matters. She has been both an active tournament shooter as well as a bowhunter.

Thousands of Virginia archers have benefitted tremendously from the unselfish contributions of Mrs. Western. On their behalf I respectfully request that the NFAA Board of Directors Council award her the Medal of Merit.

Carp hunting probably will not replace the excitement of a trophy buck standing under your tree stand, but it has been known to help a few bowhunters make it through the summer while waiting for bow season to open.

3. If the tournament is a success, the VBA would play a big role in bringing archery to the Law Enforcement Olympics nationwide.

The membership of Northern Virginia Archers voted for the tournament and I then presented the idea to the Fraternal Order of Police, D. C. Lodge #1. The general membership voted to get with NORVA for the tournament.

I next approached John Stockman, Virginia's NFAA Director, to present the idea to the next VBA meeting. The officers of VBA and those attending thought it was a good idea and gave their approval with the condition that it could be scheduled at a time which would not conflict with any existing tournament in Zone #2. After consulting John Street, VBA's Field VP, NORVA, and the FOP Lodge we settled for an Animal Round for May 10 and 11. The FOP Lodge sent out invitations to all the FOP Lodges in Northern Virginia and Maryland. With the scheduling of my work hours and court time, we were unable to make the *FLIGHT* publication cut off.

## Guest Editorial

The Olympic Games. One of the most coveted events and archery is very fortunate to be able to be represented in these wonderful games. But, why is it that many archers feel that it isn't represented in the right way? "Why is it that recurve/fingers are allowed and not someone else?" "When will FITA allow the compounds into their organization?" And, "Shouldn't the Olympic Committee drop recurve/fingers for compound/releases? They shoot the higher scores!"

Well, believe it or not, these are comments made in the United States and possibly starting to spread around the world. Is it the best way to go about getting compounds into the Olympic Games; to drop recurves? I don't think so. I know, I shoot a recurve and I am one-sided, right? Wrong! Actually, I want more than just one representation in the Olympics for archery. I want recurve/fingers, compound/releases, compound/fingers, and crossbows. Why not a bowhunter's round like maybe moving targets?

You may think I am a little off my rocker, but these events are very possible. Shooting sports (rifle, pistols, etc.) has eleven (11) events in the Olympics representing: Men's air rifle, Men's English match rifle, Men's smallbore rifle (three positions), Men's running game target, Men's clay target trap shooting, Men's skeet shooting, Men's free pistol, Men's rapid fire pistol, Women's air rifle, Women's rapid-fire pistol, Women's air rifle, Women's small bore rifle, and Women's sport pistol. The National Rifle Association (NRA) had twenty-three shooters at the 1984 Summer Olympic Games in Los Angeles. The National Archery Association (NAA) had six archers. The NRA could have won eleven gold medals. The NAA could have won two.

The main reason there are several divisions in the Shooting Sports and only one in archery is because Shooting Sports have united into one organization. Each event in shooting governs their own programs, while an umbrella organization oversees all events to make sure there are no major problems. It is similar to the United States Olympic Committee which oversees every olympic sport body, but has no real major control of the sports themselves. Instead of working against each other, possibly like archery is doing, the NRA has approximately two million members.

That sounds like a lot of members, but archery has close to 1.8 million people who shoot one form of archery or another. We just don't have any organization which caters to all types of archery. And let me tell you, the NRA is only 5% (approx.) competitors. The rest of the members join for the choice of magazines, gun lobbying, and to take advantage of other programs.

Now, let's look at United States Archery. We have the Professional Archers Association (PAA), National Field Archery Association (NFAA), National Archery Association (NAA), Bowhunters Who Care, Fred Bear Sports Club, National Bowhunter Education Foundation, Pope and Young Club, and Professional Bowhunters Society. I think I have covered most of them. There are at least two International Associations, The International Field Archery Association (IFAA) and Fédération Internationale de Tir à l'Arc (FITA). There are a couple of crossbow associations and international associations, also. Is it a wonder why archery has only one style of archery represented in the Olympics?

What we need is to get organized. Promote all aspects of archery not just the one you love. Let's face it, you are in archery because you really enjoy it, no matter what style, so why not let others enjoy their style under one major organization? If we ever want to see all of archery in the Olympics and to grow, we will have to get together. Now the most difficult questions; *Who will be the first to make a move towards unity?*




Dear VBA Members:


## Massanutten Archery Club
