## VBA Meeting Highlights

The Board of Directors of the Virginia Bowhunters Association is taking under consideration suggestions and possible solutions to the problems facing our State Shoots regarding time limits and the disqualification of groups of archers from future state tournaments.

As most of you are well aware, we have had our share of troubles at both our State Open and Closed Championships this year with archers exceeding the announced time limits and being disqualified from the tournament. Having this happen within our state is, we feel, unfortunate and unnecessary, but resolvable. The Executive Board is taking under advisement several possible and workable solutions and is inviting any input from the membership which would be helpful. More positive measures on this issue will be cited in the next *Flight*.

The thoughts of some concerned members are already published elsewhere in this issue and ALL letters sent to this editor will be published to broaden the opinions of how is best to handle this situation.

In other news from the recent VBA meeting, our Conservation Vice-President reports that there is funding available to clubs which would like to plant seedlings or do other conservation work on their ranges.

It was decided that VBA will conduct another bowhunting raffle next year. VBA made a \$608.00 profit this year on the raffle. President Enders formed a committee chaired by Bill Reeves to study way to perhaps improve future raffles.

## RILEY PUCKETT ON TIME LIMITS

It's taxing the patience of archers everywhere who constantly are stacked up behind freestylers—no one enjoys waiting 20 or 30 minutes at each target. Certain styles lend themselves to fast shooting, others to slow, but I'm convinced that scores have more control over who shoots slow or fast, if for instance scores for one style are in the 475-500 range. A loss of one point is not critical, but if you know your competition may not drop 10 points on an entire round, each point becomes desperate. On one hand you have an archer trying to accumulate points, on the other you have one trying desperately not to drop one. Herein lies our problem—some way must be found to get these archers through 28 targets at approximately the same time. The one way that has already been tried—TIME LIMITS—has failed miserably. You can't force an archer to shoot faster than his dedication or determination allows him to. So let's focus our attention on other ideas that hold more promise. The ideas that have been mentioned to me are: 1) Throw out the freestylers. A lot of people no doubt like this one, but our purpose is to promote archery

and all archers. 2) Give freestylers a 1 hour head start and let um go. This idea deserves some consideration and probably with little effort could be worked out. 3) Put 4-stakes on all targets. I shot the Maryland "GOLD CUP" which was 4-staked and 4 "AA" freestylers finished that round in 3 hours 45 minutes. This idea has only one drawback—it speeds up all archers and you still have the fast waiting on the slow. 4) And probably the one that makes more sense. Allow only 3 freestylers to a group, on most all targets they can shoot 3 abreast. A normal round for 4 freestylers is about 6 hours or 360 minutes, to walk to the target, score and proceed to next target consumes approximately 112 minutes so we have 248 minutes to shoot 448 arrows which approximates 30 seconds per shoot. Eliminate 112 shots we save 55 minutes + 15 scoring for a total of 1 hour 10 minutes. If freestylers shoot 3 abreast even more time can be saved making this style one of the fastest instead of the slowest.

Thanks for the ear, enjoyed your fellowship and hope to see you all next year.

1. (Manahoac) The Charter fee be increased by \$2.00 to cover cost of new NFAA handbook.

2. (Walton Park) CFSBH be added to Young Adult division. We feel the young adult membership would increase and that these young people will be better prepared to move into the adult division and shoot the style they prefer.

3. (Warwick) There will be no tournaments conducted on the days that a State tournament is being conducted.

4. (Smythe Co.) Petition the Va. Game Commission to issue a Bowhunter Stamp.

5. (Wythe)

a. Abolish all time limits.

b. Set a time limit and require all clubs to poll each member that attends the state shoots for the amount of time.

c. Establish penalties for exceeding time limit.

d. Start tournament earlier and allow longer time limit.

The NFAA Headquarters has no membership records available between 1966 and 1970. These records were supposed to be kept by the state office and the first date an archer paid NFAA membership has to be verified before we can issue his/her Service Pin. Verification means a copy of state records, a handicap card copy or a member's own valid membership receipt, etc.

It should be stressed to NFAA members, from state level, that a CONTINUOUS membership is required to receive Service Pins. Article XL, A, B, C, D, pg. 62 of the NFAA Constitution and By-Laws.

## From the Office of the President

So you want to be a champion! The following is a list of what some archers think are the ground rules and basic requirements needed to hold that highly esteemed place in the archery world: (1) Be as rude and overbearing as is humanly possible (2) Cooperate with no one (3) Pay absolutely no attention to any of the rules and regulations set forth by organized archery and the tournament committee and (4) Expect everyone to look up to you and overlook your uncommonly bad behavior because you are the best shot around. If the above is what you are considering as a prerequisite for being a champion, please change your thinking. The above is absolutely not needed on any archery course in Virginia or for that matter in the United States of America.

At the close of our recent State Championship Tournament, a MAN of approximately eleven years of age came to me and asked, "Hey, what are you people going to do about this mess?" My answer was, "You can bet we will do something." I certainly was relieved to see that our young people were not trying to pick up some of the bad habits of some of the very people that they are expected to look up to.

It has been suggested to me that some archers be started earlier than the rest; I am 100% opposed to any idea of this type. Why should certain individuals be accorded privileges that are not given to all present. In my opinion, a true champion is an individual who: (1) Starts on time like everyone else (2) Finishes on time (unless an equipment failure occurs, then within the prescribed time and the allotted time for repairs) (3) Cooperates with the tournament officials in order to make a better run tournament (4) Follows the rules and regulations set forth by the organization (5) Finally, is a very good shot.

Remember "SCORE ALONE DOES NOT A CHAMPION MAKE."

As long as I have the power vested in me to do so, I will try to keep our tournaments fun for everyone, not just a chosen few. I will strive to discourage offenders and even discourage the participation by an archer who will not follow the rules as set forth by this state organization and our parent N.F.A.A.

Lastly, I must sincerely apologize to those of you who did take your time to write the formal complaint that was tendered to me at the conclusion of the tournament. The action that was taken at the conclusion was a part of the action required by the complaint, the other part is my sincere apology as here written with my pledge to try and keep our future tournaments clean and healthy with the task in mind to foster, expand, and perpetuate the sport of field archery in the State of Virginia.
