### Planning for Banner Year in 1979

Just finishing up from a very successful Bowhunter Jamboree, plans are already underway to improve the Club's conveniences.

Improved and better defined camping sites, a better area to display those trophy heads, and improved kitchen facilities are targeted to be completed in early 1979.

The emphasis on the '78 Jamboree was a relaxed atmosphere and fun for all. For 1979, the emphasis will still be on having fun but more awards will be available for the various classes.

The night coon shoot provided a new and different experience for a few but was very enthusiastically welcomed.

Apparently practicing at the various moving targets paid off. Those who shot at the candle flame, falling pie plates, rolling hoops, golf balls, revolving balloons, and running deer, really sharpened their skills, for as of this date, ten Sherwood members have already bagged their game. The broadhead championship proved to be very interesting. Since the distances were unmarked, some targets were really challenging. One particular target was judged by the shooters to be anywhere between 44 and 62 yards. Perhaps we hunters that missed our deer should practice judging distances a little bit more.

Sherwood's annual trophy shoot will be held April 14 and 15, 1979. This shoot is growing more popular and attracting more shooters each year. Plan now to attend.

Don't forget - just one month later - on May 12 and 13, the State Open will be hosted on our range. It is suggested that if a camping site is desired, an advance notice would be helpful.

## Frye Kills World Record Caribou and Moose



Tom Frye, member of Loudoun Bowhunters and owner of Bowhunter Tom's Archery Shop recently returned from a successful big game hunting trip to Northwest British Columbia Canada.

Frye, equipped with a 65 No. Jennings Arrowstar and Razorback 5 broadheads and braving inclement weather, bagged a new world record 600 lb. Mountain Caribou at 60 yards. He also killed a world record Cardoia Moose on the same trip; the moose will weigh about 1400 lbs.

The caribou will rank high in Boone and Crocket.

Members are urged to apply for these awards promptly. VBA bylaws require that the applications be submitted within 90 days of the kill or the applicant is required to pay the cost of the award.

Applications are available from Club Secretaries. Completed applications should be mailed to the VBA Corresponding Secretary who verifies membership and forwards the application to the Hunting Vice President.

To save postage, awards will be delivered to Club Delegates at the January VBA meeting.

## FUTURE ARCHERY SEASONS

Hunting Vice President, John Stockman, contacted the Virginia Commission of game and Inland Fisheries to determine why the 1978 bow season was several days shorter in duration than the 1977 season.

The commission provided the following response:

Regulation 6-3 (Bow and arrow hunt) is as follows: (a) Season Generally - It shall be lawful to hunt deer with bow and arrow from the second Saturday in October through the Saturday prior to the second Monday in November, both dates inclusive.

The "Season Generally", is described in this manner in order to avoid having to set a new Regulation each year because of calendar changes.

So long as Regulation 6 - 3 remains in effect, the archery season dates will be:

1978	Oct. 14 to Nov. 11
1979	Oct. 13 to Nov. 10
1980	Oct. 11 to Nov. 8
1981	Oct. 10 to Nov. 7
1982	Oct. 9 to Nov. 6
1983	Oct. 8 to Nov. 12
