## 16th ANNUAL STATE CHAMPIONSHIP SHOOT AT STAUNTON

### From The Office Of Field Vice President

As this is the first contact I've had with you, the V.B.A. membership, as an elected officer I would like to pledge to each and every member to do my best to fulfill the duties of this office to the best of my ability. I further pledge not to show any partiality to any member or club, and all decisions required of me will be made without regard to any personal feelings. I realize that the duties of this office are many, and time-consuming, but with the help and cooperation of all clubs and their secretaries, this office and all other offices can run smoothly.

#### State Shoot Information

I hope all clubs have advised their membership of the 90-day rule pertaining to competing in the State shoot. By the time you read this it will probably be too late if you do not already meet the requirements. It means simply this: you must have participated in a shoot in June, July and August, OR you must have participated in three (3) shoots during the month of August. Waiver of this rule can be made only by the Field Vice President and only upon presentation of a letter by the archer involved, explaining the reason why he had been unable to attend the shoots required. This letter must be signed by the Archer involved, and the club president should verify it with his signature also. Class "F" men and women will not be opened.

#### Special Notice to All Clubs

There will be a special V.B.A. meeting of all club delegates at Lynchburg on Saturday, September 29th, at 3:00 p.m., preceding the regular V.B.A. meeting held on Sunday. This meeting is for the sole purpose of setting up the tournament schedule for 1963. It is very important that all clubs be represented at this meeting, and all delegates should have the dates their club desires for next year. All clubs represented will be allowed four shoots, one of which may be an annual. Any club not represented by a delegate will be allowed only one shoot for each six months' period, with their dates being assigned by the Field Vice President from the available dates after the above schedule is completed. ### Platform of Martin L. Smith, Candidate for NFAA Presidency

I became interested in archery, as a sport, in 1955 because it offered a challenging method of hunting and an interesting game. My interest in the sport has steadily increased and I have been increasingly active in all phases of field archery and bow hunting and in the administrative problems involved from the club level through the state association and national level. I am a life member of the N.F.A.A. and a member of the Board of Directors of the Virginia Wildlife Federation. I have, on a national level, served as Field Governor for Virginia, Mid-Atlantic Division Representative and Vice-President—the position in which I am now serving. I have had considerable experience in the administrative and legislative affairs of the N.F.A.A. during the past three years. Even though I do not qualify as an expert in tournament competition, I hold the N.F.A.A. big game award and the twenty-pin.

Through the years, and to a limited extent, I have and still participate in the sports of tennis, golf, hunting, fishing and tournament bridge. I find limited participation in these sports broadens my outlook on problems involving organization and finances and increases my understanding of the problems facing the N.F.A.A.

I am now 62 years of age and in sound health. I am retired and for the past two years have traveled extensively. My itinerary is tentatively complete through March 1963. If elected, appropriate changes would be made in order that I could give a full measure of effort to the Presidency—the office to which I have had the honor to be nominated.

I advocate the following:

(I) A strong, well rounded program for the N.F.A.A. that will offer training for the beginning archers; interesting competition for experienced archers; interesting and realistic hunting type competition for the bowhunters; entertainment for non-shooting members of the archery family, an incentive to prospective members.

(II) The setting of minimum classification standards at National level and supervision of the classification system by the individual states.

(III) The establishment of a National Ranking System for the purpose of rewarding

## Changes

In archery it has been different. When Mr. A steps up to the pegs on Number 10 target, at Two Rivers, he will know, because of the experience by which he has become Mr. A, that it is a fifty-five yard target. He will then hold thus and so and score a sixteen on it. A Mr. A from neighboring Fredericksburg, by the same token, will probably score a sixteen on it, too. But what of Mr. E from Bridgewater? His experience is not equal to that of any of the Mr. A's. When he steps up to the Two Rivers' No. 10 he is puzzled. "What is it? A fifty or a fifty-five yard shot? I think it's a fifty, so I'll hold so." He shoots. "Oh, nuts! It's under."

This is laughable to his companions. They kid him about it and, being a good sport, he laughs with them. But he has missed a shot. A three, at least, is not added to his score and so, at the end of the tournament, he is that much farther down the line. Perhaps that three would have put him in third place, or second or even first. Let's hope that he laughs and shrugs it off, resolving to do better next time. But who doesn't think about that shot later, at some time or other? If he says to himself, "I could have had another three if I had scored with that arrow, but I didn't know the difference." What is going to happen? Will he keep on practicing until, a year or two later, he knows that it is fifty-five yards? If he is a really interested archer, he will. If he is one of those who are "trying it out," will he?

Those of us who have been in the sport a long time know that he may be one of that sizeable group of "ifs." Think back a bit. Try to count all of those aspirants that you knew who shot a while but have dropped out. Why did they do it? If they were shooting now, would your club have forty members or would it have sixty? When the writer came to Winchester, the club roster had seventy-two names on it. Now it has fifty-three. We have new members, yes. We've had new members come in every year. But where are the seventy-two original ones? Some dropped out because of economic or family or health reasons, it's true. But didn't a lot drop out because of the game? They liked the challenge when they started. It was something totally different from anything they knew. It was fun trying to hit the target. In a little while something began to happen. They liked to shoot and began to go to tournaments. But something was wrong. They

could hit the targets fairly well at Winchester, but why couldn't they do as well at Harrisonburg? They knew that the distances were similar on all courses. They had been told about the game. Yet, to their unpracticed eye, it was not the same. Fifty-five yards down hill was not the same as fifty-five yards up hill. They couldn't bring themselves to believe it and their short experience hadn't yet convinced them. It became work to keep up with the others. That's not what they wanted. They wanted the fun of shooting and, not being of the same mold as others longer in the game, not the work of having to guess the yardage and, perhaps, wrongly. They wanted to be more sure that what they were doing would bring them pleasure instead of disappointment.

Ours is not an easy game. It is a challenging game. We older shooters accepted that challenge when it was greater than it is today. We liked it then, and we still like it. As the numerous facets of tackle and methods have undergone a change, why not accept, too, the fact that the temperament of the newcomers to the game is different? They, too, have accepted the challenge of the bow and the shaft. The bows are now laminated maple and glass and the shafts are of glass and aluminum. Why, then, should they still have to shoot in the age of the ash shaft? Why should they, or we, still shoot at questionable distances with precision equipment? It is the opinion of the writer that, even tho the sport of archery has grown, we are losing would-be archers to this very fact.

individual achievement in competition at club, state, invitational, state championship, regional championship and national championship levels. Ranking points to be awarded on placing one (1) through six (6) in any class and not on the score shot. The classification system to establish classes as at present. The National Ranking System to establish the competitive achievement of the individual in relation to other competitors. The higher the calibre of tournament in which one placed, the more valuable the Ranking points awarded.

(IV) Relocation of the National Headquarters to a more centrally located city in order that all segments of the association may be better served.

(V) Reorganization and expansion of the Headquarters Business Office to provide a sound financial and business structure that will insure planned income production and

expenditures that will provide for a rapid rate of growth of the N.F.A.A. membership and services to membership.

(VI) Reorganization of the N.F.A.A. from an association of individuals into a Federation of Affiliated state associations having as a purpose the uniting of the various segments of organized archery into one organized unit that will work more effectively and efficiently to preserve, promote and advance the sport of archery in the United States. The Federation must consist of the following parts linked together with charters and elected delegates culminating in a self-governing body.

(1) *Membership*: Individual members belong to clubs that are chartered from state associations.

(2) *Chartered Clubs*: Clubs chartered with state associations elect and send delegates to the state associations.

(3) *State Associations*: State Associations chartered and affiliated with the Federation elect and send delegates to Federation Assembly. These delegates become the Board of Directors of the Federation of affiliated states.

(4) *Board of Directors*: The Board of Directors, consisting of the elected delegates from the states, as such are the self-governing source of the Constitution and By-law adoption and changes and the source of all self-governing rules and regulations governing the affairs of the Federation. The Board of Directors must be responsible to its electorate for the conduct of Federation affairs.

(5) *Executive Committee*: The Executive Committee must be elected from the membership comprising the Board of Directors for the purpose of running the day to day affairs of the Federation. The Executive Committee should be comprised of the following:

- (a) President and chairman of the Board of Directors.
- (b) Executive Vice-President and Executive Chairman of the Executive Committee.
- (c) Treasurer.
- (d) Vice-President, in charge of Publications.
- (e) Vice-President, in charge of Tournament Activities.
- (f) Vice-President, in charge of Bow Hunting Activities.
- (g) The following salaried personnel—
  - (1) Director of Promotions and Public Relations
  - (2) Secretary—Business Director
  - (3) Publisher—Editor

The Executive Committee must be responsible to the Board of Directors for the conduct of the day to day affairs of the Federation.

(VII) A revision of the Constitution and By-laws to conform with the functioning of the Federation.

(VIII) Finance the travel expenses of state delegates to the annual meeting of the Board of Directors by putting 35 cents from each full membership into a fund for the purpose.

If elected I will strive constantly to creditably discharge the responsibilities of the Presidency of the National Field Archery Association, being ever mindful of the high standards set by Mr. Richard Freeman and the desires of the membership.
