# Venison, Beef Jerky Marinade

*Also Great for Steaks and Roasts!*  
*(12 oz. marinates 4 lbs. of meat)*

*Helpful hints from Wally Whitetail  
 on making venison jerky:*



1. Cutting *across* the grain of the meat, slice venison in 1/4 inch strips.
  2. Place up to 4 lbs. of jerky strips in resealable gallon plastic bag with 12 oz. of marinade. (3 oz. to 1 lb. of meat)
  3. Remove air from bag and seal.
  4. Refrigerate for 12 to 24 hours. (The longer the better.) Turn meat at least once.
  5. Drain off marinade and place jerky strips on oven rack covered with aluminum foil. (Punch a few small holes in the aluminum foil with a fork.)
  6. Set oven on 150° with door slightly open. Dry jerky in oven for approximately 6 to 7 hours. Check every 30 minutes until done.
- Tips from Chef Winnie:* To add even more flavor, sprinkle lightly with black pepper before drying in oven. For spicy jerky, add ground red or cayenne pepper!
