

### Field Governors Report

Range inspections are going very well, even the 3D range inspections are coming around to what I expect. Beginning June 1, 1994 the new inspection forms are to be used. There are 3 changes to be aware of;

1. Line (L) changed from recommended to mandatory.

It is mandatory that on a Bowhunter/3D Range the Range inspector must be provided at the time of inspection, with a map of the range layout which will be used for the inspections. Also if an accident occurs during the shoot this may be used for Insurance purposes. A map shall show distances, direction, targets and shooting positions.

2. Line (M) is an addition. Archery range safety warning signs shall be posted on all approved NFAA 3-D ranges at the inspectors discretion.

3. Line (N) is an addition. If simulated moving targets are incorporated into the range they will be operated from behind the shooting position.

1. Bear Creek Bowmen
2. Belvoir Bowhunters
3. Prince William Archers
4. Shenandoah County Archers
5. Triangle Archers



**Results of Agenda Items from June 1994 VBA Meeting**

1. Sherwood moves that the Bylaws include the following as a standing rule: All scheduled shoots, Club or State level, provide water for drinking on every 7th target effective with the outcome of the June, 1994 VBA meeting. *(Passed)*
2. Sherwood moves that the VBA contracts for State level tournaments will be made available at the March meeting of the VBA to any Club considering a State Shoot effective, January 1995. *(Passed)*
3. Prince William moves that water be available for drinking on the range at State Outdoor Shoots - optional at Club level (at 7 target intervals). Effective: Immediately. *(Failed)*
4. Prince William Archers moves to rescind the motion approved at the September, 1993 VBA meeting pertaining to the usage of the single or 3 spot FITA target for the 1995 State Indoor and revert back to the NFAA championship face as presently used. Effective: 1995 State Indoor Shoot. *(Passed)*
5. John McLaughlin moves that the Conservation VP office be renamed Conservation/Legislative Affairs VP. The Conservation duties will remain as assigned. The Conservation Fund will support legislative affairs pertinent to the VBA. The legislative affairs VP chairs the Network Committee. Effective: Immediately. *(Passed)*
6. The Tournament and Field Archery Committee proposes the following change to Article 18: Standing Committee, Section 2.  
A Tournament and Field Archery Committee shall be established. Its membership shall be appointed by the President of the VBA and shall include a Chairman, the VBA Treasurer, the Field VP, the NFAA Director, the Tournament Director of each of the State Championship tourna-

ments (Indoor, Open, Closed, Spring 3-D and the Fall 3-D) and one member from each zone.

The primary purpose of this Committee shall be to assist the President of the VBA by establishing guidelines and verbiage pertaining to contracts between a host club and the VBA for all State Championship Tournaments. These contracts shall be generic in nature and contain specific language to properly enforce consistent range conditions and facility requirements. The scope of the contract shall not preclude any club, with a properly inspected range, from bidding on a State Championship tournament or serve to cause a Club to withdraw a bid from any State Championship Tournament. The final draft of the contracts shall have a 2/3 affirmative vote of the aforementioned members, of the Tournament and Field Archery Committee, before being presented to the President of the VBA for his approval.

Such Contracts shall be signed by:

1. President of VBA
2. Field Vice President of VBA
3. Corresponding Secretary of VBA
4. President of Host Club
5. Tournament Chairman of Host Club
6. Secretary of Host Club.

The secondary purpose of this Committee shall be to foster, expand and perpetuate all aspects of competitive archery games and other such duties as may be required by the Board of Directors.

Reason for Change: One person should not have the authority and/or responsibility of dictating his policy, personal views or conceived competitive tournament procedures on the body of the membership of the VBA. Effective Date: January, 1995. *(Tabled)*

## Hunting Vice President's Report

### ramblin' 'round

How many of you are aware that the VBA awards a trophy each year for the largest carp and gar taken with a bow? Well yours truly was not aware of it until I received an application or two. The VBA awards a trophy in each category every year but there apparently haven't been any applicants for a couple of years. In any case we will award a trophy for the largest carp and a trophy for the largest gar taken by bow no later than August 31st. There are official applications similar to the Bill Bennett application and these also must be sent to Ann Boyd. If you want to submit an application please have it in to Ann no later than October 31st.

Speaking of Bill Bennett awards, I still have a few on hand from the past season, which means that if you have not received yours then your club representative has not been at a VBA meeting this year. If you have not received your Bill Bennett award from the '93 hunting season, please contact me.

The Game and Fish Commission has decided how the law will be applied for crossbow users with a physical disability. They must be disabled in the upper body, preventing them from drawing conventional archery equipment, must have a doctor's certificate attesting to their disability on their person when hunting as well as a copy of the certificate on file with the Game and Fish Department, and must hunt on their own land. This will be in effect for the upcoming hunting season. I am sure that we will hear more on this subject when the state legislature convenes in 1995. Unless we are willing to ultimately accept full use of crossbows during the special archery season we should be prepared to notify our legislators and the Board of Commissioners now that we do support this action. My approach has been that the crossbow is NOT a bow but is more like a rifle (shoulder fired, mechanical cocking mechanism, rifle scope sight) and therefore should be allowed for use ONLY in the regular firearms season.

For those interested there will be a special resident goose season again this year. Permits will be available from regional and state offices of the Game and Fish Department.

The Virginia Outdoor Sportsman Show sponsored by the Virginia Deer Hunters Association will be held in Richmond August 12-14 at The Show Place on Mechanicsville Turnpike.

Interested in Traditional Archery? There is a group of traditional archers trying to get a statewide organization started. If you are interested call me or John McLaughlin.

Now is the time we should all be tuning up our hunting gear, shooting with broadheads from an elevated position. Don't wait until September to get started, the archery season opens on October 1. From what I've seen this is shaping up to be a super season, be ready.

## From the Office of the NFAA Director

### *Revised News Release*

### 1994 NFAA Liability Insurance Questions Answered

The purpose of the NFAA Club/Shop Liability Insurance Coverage is to always protect the Club and its Members.

**1. Who is the named Insured?**

The NFAA affiliated Club/Shop who has purchased the NFAA Liability Insurance Coverage.

**2. Does the program provide medical coverage for accidents which occur on Club/Shop Property?**

Yes, the program offers up to \$5,000 for non-insured persons.

**3. If a Club/Shop hosts a tournament and an accident occurs, is the Club and its members covered against a suit filed by the injured party?**

Yes, the purpose of the Liability Insurance coverage is to always protect the Club and its Members. If an individual is injured and files a claim against the Club and all of its members as individuals, the Club and the members of the Club would be covered against a claim or suit.

**4. Suppose a Club/Shop member accidentally shoots a fellow member or a non-member, would coverage apply under the program?**

If the Club/Shop member or the Club/Shop is sued for negligence at a NFAA sponsored activity the policy will defend the Club and its members.

**5. Would a Club/Shop member or non-Club/Shop member be covered if he/she shot an arrow from inside Club/Shop property and hit someone outside the Club/Shop?**

The Club/Shop would be defended against any suit alleging injury in this circumstance. The member, however, would be covered only if acting on behalf of the Club/Shop. Non-members of the Club would not be defended.

**6. What if a trespasser is injured on Club/Shop property?**

If the Club/Shop is deemed legally liable for the injury, then they would be defended by the program. Obviously, either children or adults assume some liability when they trespass.

**7. If a minor is left unattended by the parent/guardian, during a Club/Shop function, such as a tournament, and the minor is injured, would the Club/Shop be covered?**

If the Club/Shop is deemed legally liable for a covered claim, then yes.

**8. When the Club/Shop holds functions, such as a monthly meeting, banquet or a booth, at a place other than their own range/shop, are they covered by the policy?**

Yes, the Club/Shop is covered. The policy is comprehensive and covers all Club/Shop sponsored activities.

**9. Can we name our Landlord or other party as an additional insured on our policy?**

Yes. Simply complete the additional insured information on the Insurance application and a Certificate of Insurance will be provided for the Additional Insured.

**10. Is my landlord or additional insured covered for the same limits as my Club/Shop?**

Yes. However, the limits are shared.

**11. I am an NFAA member and an officer of our Club which carries the Club Liability Insurance. I am involved in the decision making of our Club. Am I covered under the Liability Policy?**

Only for Bodily Injury and/or Property Damage suits.

**12. My Club/Shop is not affiliated with the NFAA. Are we still eligible for this program?**

No. The economical liability insurance is only available to current NFAA affiliated Club/Shops

**13. I am a NFAA member of a NFAA Club that is on a hunting trip. Am I covered while I am hunting?**

No. The policy is provided to cover the Club and members acting on behalf of the Club during Club functions. A personal hunting trip would not be covered.

**14. In my Shop I repair archery equipment. If an individual is injured as a result of my repairs, will I be covered?**

Our policy includes "Products/Completed Operations" coverage. Completed Operations basically means if an individual brings in their bow to be restrung and when the bow is then used and the string breaks, injuring the individual, the Shop is covered under our current policy as "Complete Operations."

**15. Are Cross Bows covered under the Liability Insurance?**

This insurance does not apply to "bodily injury", "property damage", "personal injury", "advertising injury" or medical expenses for "bodily injury" arising out of the ownership, maintenance, use or operation of any cross bow.

**16. Does the Policy provide Host Liquor Liability Coverage?**

Yes, when alcoholic beverages are served at Club Meetings to members and guests. However, the exclusion would apply if the Club is deemed responsible for causing or contributing to the intoxication of any person; The furnishing of alcoholic beverages to a person under the legal drinking age or under the influence of alcohol, including any statute, ordinance or regulation relating to the sale, gift distribution or use of alcoholic beverages.

We advise against mixing alcohol and archery activities.


ad and doesn't know it yet." The cougar quickly climbed another twenty feet up into the tree, started to lose his balance, and then expired right in the crotch of two branches. Stan yelled, "NO! Not up there you \_\_\_\_!"

Now we had a major problem. How do I get my lion out of a tree 70 feet up, when there were no branches at the bottom of the tree for at least 10 feet. Stan suggested I climb up and knock it out. I asked him if he was a little lightheaded from the walk. It looked like we would have to come back tomorrow with the horses and a chain saw and take the tree down. I was grateful to say the least when Scott, who is of medium build and athletic, volunteered to climb up and get my lion. Slowly but surely he made it up to the lion, and gave it a good push. I thanked God that he had been able to climb that big tree safely. Scott sure saved us a lot of time and trouble.

The cat was a big tom, and I finally had my Pope & Young mountain lion - just what I came for! We went to work cutting up the lion, and packed the meat, head and hide in our back packs, and Stan rewarded his dogs for their work. It was time to start the long trip back to the snowmobile. This time the walk didn't seem as long, and this time I wasn't dreaming.

Stan Garvey has only seven lion hunters a season, as the quotas for the different areas fill up quickly. Stan is a natural at hunting mountain lion, and his dogs are excellent. Stan's policy is, if a hunter doesn't get his cougar during his week long hunt (a rare occasion), then he is welcome to come back the next year at no charge. Very few outfitters offer this.

I booked my hunt through October Adventures.



## Tournament and Field Archery Committee Report

As some of you may have heard, the vote from the VBA and the NFAA is to change the scoring system on Field and Hunter rounds. This new target will be optional for the 1995 season and mandatory for the 1996 season. One effect of the new target is that the current VBA classification system will need to be reworked.

In anticipation of the new target's arrival, the Tournament and Field Archery Committee was assigned the task of providing the base needed for reclassification due to the new scoring rules. What the change involves is basically the splitting of the four ring, with half becoming a three and half a five, the looks and size of the target staying the same. This change will allow some Archers to shoot higher scores while others may even stay close to where they are now.

This is where we need your help to provide us with some important information. Our plans are to collect the necessary data from the membership who will shoot a field round using the

new score and the old score together for data analysis. With this information we plan to provide an accurate class system, trying to maintain the same class breaks. As with other fact finding projects, the more people who help with this, the closer the results will be to providing classes that we all can live with. Our present system has taken years to tweaking and adjusting to get where we are now, let's not let it go to waste.

Remember the new score counts a five out to the thin black line in the white ring and a three from there out, also count your X's.



# Bowhunter Education Program Instructor Course


On June 4, six VBA members attended a BEP Instructor workshop at Bowhunters of Rockingham facilities near Harrisonburg, Virginia. These members spent the day receiving an abbreviated version of the basic Bowhunter Education Program course supplemented by a discussion of innovative ways of presenting the course.

The latest training aids were demonstrated. These included a life size 3D deer with one side showing vital organs. A smaller version of this type deer was also shown. It is normally passed around from student to student and has proven to be an effective and popular training aid. A spiral bound four page overlay of whitetail deer anatomy was also presented and discussed.

The instructors encouraged participation by the attendees who were all experienced bowhunters who in gen-




*BEP Instructors: From left to right: Virgil II the 3D deer, Charley Kappleman, and Roger Pearce.*

eral want to give back to the sport of bowhunting some of the satisfaction they have derived from it. They feel that by becoming instructors they can use their experience and knowledge to help others enjoy the sport in a safe, ethical, responsible manner.

The course places a priority on recovering game. In keeping with this emphasis, Randy Gebr laid down two challenging blood trails which the other five instructor/students unravelled. Each trail was laid to reinforce points discussed in the classroom.




